### **PCCB Technical Session on Coherence and Coordination of Capacity- building**

#### **Concept Note**

#### **Background:**

As part of its 2021-2024 workplan (Activity A.3.1), the PCCB will be organizing a technical session on coherence and coordination of capacity-building at the 3<sup>rd</sup> Capacity-building Hub at COP 26.

Enhancing coherence and coordination of capacity-building under the Convention and the Paris Agreement is one of three priority areas of the PCCB. To this end, the committee, in early 2021, launched an informal coordination group for capacity-building under the Convention and the Paris Agreement (ICG) to provide a conducive space for representatives of constituted bodies, operating entities and relevant processes under the Convention and the Paris Agreement to coordinate climate change related capacity-building plans and activities, and allow for better sharing of information, coherence, and identification of opportunities.

The technical session will focus on recent and future work of the ICG and examine key aspects of coherence and coordination of capacity-building under the Convention and Paris Agreement. Speakers will include PCCB members, members of the ICG, and Party representatives.

#### **Objectives:**

- Share information on efforts undertaken by the ICG to enhance coherence and coordination of capacity-building with Parties and Non-Party stakeholders
- Receive feedback from Party and non-Party stakeholders on ICG work to date and guidance for future work related to enhancing coherence and coordination of capacity-building
- Identify good practices for further enhancing coherence and coordination of capacity-building under the Convention and the Paris Agreement
