### Conclusions and recommendations from the 2023 joint meeting of lead reviewers



Paragraph 13. The LRs requested the secretariat to continue exploring ways to involve all eligible and interested reviewers in current review/analysis processes and to report its findings to the LRs at their next meeting.



#### Improvements to the RoE platform

Technical updates to facilitate management of the platform and prompt actions to improve communication with Parties



**Number of participations** in reviews and technical analysis per expert are publicly available on the RoE website



**New nomination tasks:** Technical expert review under the Paris Agreement and Review of reports submitted under Article 6, paragraph 2 of the Paris Agreement



**Development of support material for NFPs and custodians** to clarify nomination and approval procedures



**Increased support offered to NFPs:** during SB58 the Transparency Division met with NFPs featuring a high number of pending approvals in the RoE to help them overcome technical constraints



Increased frequency of communications with experts to announce examination periods, live Q&A sessions, hands-on training, among other opportunities



#### **Engagement of new experts**

The secretariat made an effort to involve a higher number of new experts in the current BR/NC, BUR and GHGI review/analysis processes

#### Since March 2023:



Greenhouse Gas (GHG) inventory technical review process: 67 experts (48 per cent) participated for the first time



**Biennial Update Reports (BUR)** technical analysis process: **19 experts** (30 per cent) participated for the first time



Biennial Report (BR) / National Communication (NC) technical review process: 96 experts (42 per cent) participated for the first time
