### **Background note**

#### **I. Background**

1. As per activity 2 of the workplan of the forum and its KCI for the fifty-second to sixty-third sessions of the subsidiary bodies), the Katowice Committee of Impacts (KCI) is to identify country-driven strategies and best practices on just transition of the workforce and creation of decent work and quality jobs and on economic diversification and transformation focusing on challenges and opportunities from the implementation of low greenhouse gas emission policies and strategies towards the achievement of sustainable development. The activity is to be implemented at its meeting taking place in conjunction with SB 54 and SB 58.
2. The KCI is to use modalities taking inputs from experts, practitioners and relevant organisations; and providing concrete examples.

#### **II. Scope of the note**

3. This background note contains in its annex contains (i) draft call for inputs from experts, practitioners and relevant organisations; and (ii) draft outline of compilation of concrete examples on country-driven strategies and best practices on just transition of the workforce and creation of decent work and quality jobs and on economic diversification and transformation focusing on challenges and opportunities from the implementation of low greenhouse gas emission policies and strategies towards the achievement of sustainable development.

#### **B. Possible action by the Katowice Committee of Impacts**

4. The KCI will be invited to consider the draft call for inputs and draft outline for preparing the concrete examples and provide guidance on further work to prepare concrete examples.

The example should focus on challenges and opportunities encountered while implementing low greenhouse gas emission policies and strategies towards the achievement of sustainable development that have led to country-driven strategies and best practices on just transition of the workforce and creation of decent work and quality jobs and on economic diversification and transformation.
