An opening ceremony, to be attended by His Excellency Mr. Frank Bainimarama, President of COP 23/CMP 13/CMA 1.2, His Excellency General Surasak Kanchanarat, Minister of Natural Resources and Environment of the Kingdom of Thailand, Mr. Michal Kurtyka, President Designate of COP 24, Ms. Patricia Espinosa, Executive Secretary of the United Nations Framework Convention on Climate Change and Mr. Kaveh Zahedi, Officer in Charge of the United Nations Economic and Social Commission for Asia and the Pacific (UNESCAP) will mark the opening of the sessions.

A video message from the Deputy Secretary-General of the United Nations Ms. Amina J. Mohammed will be delivered during the ceremony.
