The secretariat will provide a summary of the main outcomes of the twenty-third session of the Conference of the Parties and the thirteenth session of the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol, as well as the forty-fifth and forty-sixth sessions of the Subsidiary Body for Scientific and Technological Advice and the Subsidiary Body for Implementation and the second and the third parts of the resumed first session of the Ad Hoc Working Group on the Paris Agreement, in particular, in relation to any issues that might have relevance for the work of the Committee.
