Status of submission and review of reports under the Kyoto Protocol

Note by the secretariat

1. This note provides information on the status of submission and review of the supplementary information necessary to demonstrate compliance by relevant Parties with their commitments under the Protocol, in accordance with Articles 7 and 8 of the Kyoto Protocol, including the annual greenhouse gas (GHG) inventories submitted in 2021 and 2022 by Parties included in Annex I (hereinafter, Annex I Parties)¹ in accordance with decision 15/CMP.1, as at 31 May 2022 and the seventh national communications (NC7s) by Annex I Parties, in accordance with decision 15/CMP.1 in conjunctions with decisions 3/CMP.11 and 4/CMP.11.

Annex I Parties in the second commitment period (2013–2020)

2. There are 42 Annex I Parties to the Kyoto Protocol.² Thirty-eight of them have a quantified emission limitation or reduction commitment (QELRC) inscribed in the third column of the table in Annex I to the Doha Amendment as contained in Annex I to decision 1/CMP.8³ for the second commitment period. Supplementary information is submitted by these Parties in their annual greenhouse gas inventory submissions, pursuant to Article 7, paragraph 1, of the Kyoto Protocol, and in accordance with decisions 15/CMP.1, 2/CMP.8, 6/CMP.9 and 3/CMP.11.

3. Japan, New Zealand and the Russian Federation are Annex I Parties that had a QELRC for the first commitment period but do not have a QELRC for the second commitment period. However, the CMP decided, through decision 3/CMP.11, that these Parties continue to have certain limited reporting obligations in relation to elements of the information usually reported under Article 7, paragraph 1, of the Protocol.⁴ In addition, the reporting obligations under Article 7, paragraph 2, where these are related to commitments under the Protocol other than those under Article 3, appear to be applicable to these Parties, including in the context of supplementary information in their NC7s.⁵

4. Belarus, Cyprus, and Malta did not have a QELRC for the first commitment period but have QELRCs for the second commitment period. Their reporting obligations under Article 7, paragraph 1, of the Protocol are triggered in relation to the second commitment period. As at 31 May 2022, Belarus had not submitted its report to facilitate the calculation of the assigned amount for the second commitment period.⁶ Kazakhstan⁷ did not have a QELRC for the first commitment period but had a QELRC for the second commitment period. Ukraine had a QELRC for the first and second commitment periods. Following the entry into force of the Doha Amendment on 31 December 2020, the period of its voluntary implementation by Parties, as provided for in paragraph 6 of decision 1/CMP.8, expired. Neither Kazakhstan nor Ukraine has accepted the Doha Amendment.

5. Turkey does not have a QELRC for the first or the second commitment periods. In the absence of commitments under Article 3 of the Protocol, its reporting obligations under Article 7, paragraph 1, of the Protocol do not appear to be triggered. At the same time, the reporting obligations under Article 7, paragraph 2, where these are related to commitments under the Protocol other than those under Article 3, appear to be applicable to this Party, including in the context of supplementary information in its NC7.⁸

Greenhouse gas inventory submissions 2021

6. As indicated in the previous note on the status of submission and review of reports under the Kyoto Protocol,⁹ the secretariat received 42 annual inventory submissions for 2021 from Annex I Parties to the Kyoto Protocol. Table 1 updates the information on submission dates. Forty of these submissions¹⁰ contain supplementary information under Article 7, paragraph 1, of the Kyoto Protocol, in accordance with decision 15/CMP.1 in conjunction with decision 3/CMP.11.

7. The secretariat coordinated reviews of 21 of submissions by Annex I Parties indicated in paragraph 6 above.¹¹ Originally the plan was to undertake 2 desk reviews, 4 centralized reviews and 10 in-country reviews. Due to the COVID-19 pandemic the planned centralized reviews and in-country reviews were conducted as remote centralized reviews. Therefore, 15 submissions were reviewed as remote centralized reviews¹² and 6 as desk reviews.¹³ The reviews took place between 30 August and 23 October 2021.

8. As at 31 May 2022, 14 review reports have been published on the UNFCCC website.¹⁴ The twelve containing reviews of reporting obligations of Parties to the Kyoto Protocol were forwarded to the Compliance Committee to the Kyoto Protocol.

Greenhouse gas inventory submissions 2022

9. As at 31 May 2022, the secretariat received 42 annual inventory submissions for 2022 from Annex I Parties (see table 2 below). The status reports are being prepared by the secretariat and will be published on the UNFCCC website by the end of June.¹⁵ Forty of the submissions¹⁶ contain supplementary information under Article 7, paragraph 1, of the Kyoto Protocol provided in accordance with decision 15/CMP.1 in conjunction with decision 3/CMP.11.

10. The secretariat is coordinating reviews under the Kyoto Protocol of 37 of the submissions referred to in paragraph 9 above ¹⁷, either as centralized review or in country review. The reviews are planned for the period from 5 September to 10 December.

New Zealand had a QELRC in the first commitment period but does not have a QELRC for the second commitment period. Therefore, it is not required to submit an initial report (see paragraph 3). However, it submitted a report to facilitate the calculation of its emissions budget for the period 2013–2020 containing information relating to its base year as well as other relevant information. The Subsidiary Body for Scientific and Technological Advice, at its forty-first session, took note that a Party included in Annex I to the Convention that is a Party to the Kyoto Protocol with a QELRC in the first but not the second commitment period may request the expert review team to review, as part of its review of that Party's annual inventory for the first year of the second commitment period, information relating to that Party's base year. The review of the report of New Zealand was conducted in accordance with the "Guidelines for review under Article 8 of the Kyoto Protocol".

Reports to facilitate the calculation of the assigned amount for the second commitment period of the Kyoto Protocol

11. In 2016, the secretariat received 35 reports to facilitate the calculation of the assigned amounts for the second commitment period.¹⁸ The secretariat organized the reviews of these reports in conjunction with the reviews of the 2016 submissions. The secretariat received the reports to facilitate the assigned amount of Kazakhstan and Monaco on 4 July 2017 and 4 August 2017, respectively. The secretariat organized the reviews of these reports in conjunction with the reviews of these reports in conjunction with the reviews of the 2017 submissions (for Monaco) and 2018 submissions (for Kazakhstan). As at 31 May 2022 Belarus had not submitted its report to facilitate the calculation of the assigned amount for the second commitment period. All the published review reports¹⁹ are available on the secretariat's website.²⁰

Submission of national communications

12. In accordance with decision 9/CP.16 and following the requirements of Article 12, paragraphs 1 and 2, of the Convention, Parties included in Annex I to the Convention are required to submit to the secretariat a seventh national communication by 1 January 2018. In accordance with decision 7/CMP.8, Annex I Parties to the Kyoto Protocol are to include in their national communications the necessary supplementary information under the guidelines established under Article 7 of the Kyoto Protocol.²¹

13. The "Guidelines for review under Article 8 of the Kyoto Protocol" (at paragraph 139 of the annex to decision 22/CMP.1 in conjunction with decision 4/CMP.11) stipulate that "If a Party included in Annex I expects difficulties with the timeliness of its national communication submission, it should inform the secretariat before the due date of the submission. If the national communication is not submitted within six weeks after the due date, the delay shall be brought to the attention of the COP/MOP and the Compliance Committee and made public".

14. As at 11 August 2021, the secretariat received NC7 from 41 Annex I Parties. Ukraine has not submitted its NC7 yet.

15. The secretariat coordinated reviews of 40 Annex I Parties following the Article 8 guidelines of the Kyoto Protocol. Thirty of the individual reviews of these submissions were scheduled as in-country reviews from February 2018 to April 2019 and the other ten were reviewed in centralized reviews in Bonn, Germany. Once completed, technical review reports were published on the UNFCCC website and forwarded to the Compliance Committee. The review of NC7 of Belarus, submitted in September 2019, had been scheduled for beginning of 2020 as in-country in-person review. The in-country review of Belarus NC7 had to be postponed due to the global pandemic and is planned to be conducted during the BR5/NC8 review cycle.

16. Information on the status of submission of NC7 as at 31 May 2022 is included in table 3.
