The secretariat will provide a summary of the main outcomes of the twenty-fourth session of the Conference of the Parties and the fourteenth session of the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol, as well as the forty-ninth and fiftieth sessions of the Subsidiary Body for Scientific and Technological Advice and the Subsidiary Body for Implementation and the third part of the resumed first session of the Conference of the Parties serving as the meeting of the Parties to the Paris Agreement, in particular, in relation to any issues that might have relevance for the work of the Committee.
