In accordance with section II, paragraph 10, of the "Procedures and mechanisms relating to compliance under the Kyoto Protocol" contained in the annex to decision 27/CMP.1, the Committee, unless it decides otherwise, is to meet at least twice each year, taking into account the desirability of holding such meetings in conjunction with meetings of the subsidiary bodies under the Convention.
