4. Consideration of the question of implementation with respect to Monaco

3. The question of implementation with respect to Monaco is contained in document CC/ERT/ARR/2018/8, which was received by the Compliance Committee on 23 March 2018 under section VI, paragraph 1, of the "Procedures and mechanisms relating to compliance under the Kyoto Protocol"¹ and rule 10, paragraph 2, of the "Rules of procedure of the Compliance Committee of the Kyoto Protocol". The question of implementation indicated in this document was allocated to the enforcement branch on 3 April 2018 and sent to the branch on 4 April 2018 under section VII, paragraph 1.

4. On 19 April 2018, the branch decided to proceed under section VII, paragraph 2, and section X, paragraph 1 (a) (CC/2018/1-2/Monaco/EB).

5. Monaco did not submit any written submission in accordance with paragraph 1 of section IX, paragraph 1 (b) of section X, and rule 17 of the rules of procedure, and did not request a hearing under paragraph 1 (c) of section X. The Party concerned, however, participated via electronic means during the discussions of the branch on the question of implementation at its 31st meeting (29-30 May 2018).

6. The branch adopted a preliminary finding of non-compliance on 30 May 2018 (CC-2018-1-3/Monaco/EB).

7. The diplomatic agent of Monaco received the written notification of the preliminary finding on 1 June 2018. The deadline for a written submission of Monaco under section X, paragraph 1 (e) was 2 July 2018.

8. No written submission under section X, paragraph 1 (e), was received from Monaco.

9. At its 31^{st} meeting, the enforcement branch agreed to consider the final decision on this matter during its 32^{nd} meeting.
