4. Consideration of the questions of implementation with respect to Kazakhstan and whether to apply adjustment

3. The questions of implementation with respect to Kazakhstan are described in documents CC/ERT/IRR/2019/1 and CC/ERT/ARR/2019/4. In addition, document CC/ERT/ARR/2019/4 also indicates a disagreement whether to apply an adjustment. The documents were received by the Compliance Committee on 19 February 2019 under section VI, paragraph 1, of the “Procedures and mechanisms relating to compliance under the Kyoto Protocol”¹ and rule 10, paragraph 2, of the “Rules of procedure of the Compliance Committee of the Kyoto Protocol”. The questions of implementation indicated in these documents were allocated to the enforcement branch on 28 February 2019 and sent to the branch under section VII, paragraph 1.

4. On 14 March 2019, the branch decided to consider the questions of implementation and the disagreement whether to apply an adjustment together, following the expedited procedures as contained in paragraph 1 of section X, taking into account the possibility of aligning both procedures set out in paragraph 7 of rule 25ter of the rules of procedure (CC-2019-1-2/Kazakhstan/EB).

(a) Advice from experts

5. In deciding to proceed, the branch also decided to seek expert advice, in accordance with section VIII, paragraph 5, and rule 21 and, subsequently, adopted the decision on expert advice contained in document CC-2019-1-3/Kazakhstan/EB.

6. The branch may wish to consider advice in relation to the reports of the expert review team referred to in paragraph 3 above as well as advice in relation to material presented by Kazakhstan in any written submission it may make on or before 22 April 2019.

(b) Elaboration and adoption of a decision

7. The branch is to adopt, as appropriate, a decision or decisions on these matters pursuant to section IX, paragraph 4, and section X, paragraph 1 (d) and Section V, paragraph 5 (a).
