2. The branch will be invited to consider the organization of its work for the meeting, including its schedule.

4. Consideration of the questions of implementation with respect to Monaco

3. On 1 October 2019, 17 February 2020, 19 August 2020 and 28 September 2020, respectively, Monaco submitted its third, fourth, fifth and sixth progress reports (CC-2018-1-9/Monaco/EB, CC-2018-1-10/Monaco/EB, CC-2018-1-11/Monaco/EB and CC-2018-1-12/Monaco/EB) on the plan it had developed pursuant to the final decision of the enforcement branch (CC-2018-1-5/Monaco/EB).

4. The branch will be invited to consider the progress reports of Monaco, and the ERT report of the individual review of the annual submission of Monaco submitted in 2019 contained in document FCCC/ARR/2019/MCO, and take any action it deems appropriate.

5. Consideration of the questions of implementation with respect to Kazakhstan

5. In accordance with paragraph 2 of section XV and paragraph 3 of rule 25 bis of the rules of procedure, the branch adopted the decision on review and assessment (CC/2019/1/12/Kazakhstan/EB) by electronic means on 28 July 2020 which stated that the revised plan submitted by Kazakhstan set out and addressed in separate sections each of the elements specified in paragraph 2 of section XV and if implemented, along with the recommendations of the branch, is expected to remedy non-compliance.

6. The new questions of implementation with respect to Kazakhstan are described in document FCCC/ARR/2019/KAZ. The document was received by the Compliance Committee on 3 September 2020 under section VI, paragraph 1, of the “Procedures and mechanisms relating to compliance under the Kyoto Protocol”¹ and rule 10, paragraph 2, of the “Rules of procedure of the Compliance Committee of the Kyoto Protocol”. The questions of implementation indicated in these documents were allocated to the enforcement branch on 8 September 2020 and sent to the branch under section VII, paragraph 1.

7. On 30 September 2020, the enforcement branch, using electronic means, conducted a preliminary examination and decided to proceed with the questions of implementation
