Thirty-seventh meeting

5 July 2022 13:00 – 18:00 CEST Hybrid Meeting Bonn, Germany

Report on the meeting

1. Opening of the meeting

1. The secretariat welcomed participants and reported that the enforcement branch, with its decision on 27 of April 2022 (see document CC/EB/2022/1, attached as annex I), elected Ms. Paulette Bynoe as chairperson and Ms. Karoliina Anttonen as vice-chairperson using electronic means.

2. The chairperson of the enforcement branch, Ms. Bynoe, opened the thirty-seventh meeting of the enforcement branch and welcomed the members and alternate members of the branch to the meeting. The list lof members and alternate members present at the meeting is contained in annex II to this report.

3. At the request of the chairperson, the secretariat ascertained the existence of quorum, and provided information on the administrative, logistical and housekeeping arrangements. The secretariat also informed the meeting that a live broadcast link to the meeting had been posted on the UNFCCC website, where a recording of the meeting would also be available.

2. Round of introduction of members and alternate members of the enforcement branch

4. The members and alternate members of the enforcement branch introduced themselves and detailed their experience and professional backgrounds.

3. Adoption of the agenda and organization of work

5. The enforcement branch adopted the provisional agenda without changes ($\underline{CC/EB/37/2022/1}$) and agreed to conduct its work as presented by the chairperson in the indicative schedule of the meeting.

6. As per rule 9 of the "Rules of procedure of the Compliance Committee of the Kyoto Protocol"¹, the branch conducted its business in open session and agreed to address agenda item 4 (Consideration of the question of implementation with respect to Kazakhstan) in closed session.

4. Consideration of the question of implementation with respect to Kazakhstan

7. The chairperson provided a summary of the proceedings since the preliminary finding with respect to Kazakhstan, which was adopted by the enforcement branch during its 35th meeting on 10 November 2020 (<u>CC-2020-1-2/Kazakhstan/EB</u>). On 13 January 2021, the enforcement branch adopted the final decision with respect to Kazakhstan (<u>CC-2020-1-4/Kazakhstan/EB</u>) by electronic means, confirming the preliminary finding.

8. In accordance with paragraph 6 of the final decision and paragraphs 24 and 29 of the preliminary finding, the first progress report was to be submitted by Kazakhstan, in accordance with section XV, paragraph 3, of the procedures and mechanisms relating to compliance under the Kyoto Protocol (decision 27/CMP.1), and the decision on the review and assessment of the plan (CC-2019-1-12/Kazakhstan/EB) no later than 31 January 2021 with subsequent progress reports to be submitted periodically thereafter, at least once every six months, to address the questions of implementation raised in the 2017 annual review report (ARR), 2017 in-depth review report (IRR) and 2019 ARR, in addition to the recommendations of the enforcement branch contained in the review and assessment of the revised plan (CC-2019-1-12/Kazakhstan/EB). Kazakhstan submitted its first progress report (CC-2020-1-5/Kazakhstan/EB) on 22 February 2021, its second progress report on 12 August 2021 (CC-2020-1-6/Kazakhstan/EB), its third progress report on 4 February 2022 (CC-2020-1-7/Kazakhstan/EB) and an advance copy of its fourth progress report on 30 June 2022.

9. At its 37th meeting, the enforcement branch considered the third progress report and the advance copy of the fourth progress report submitted by Kazakhstan in accordance with paragraph 29 of the preliminary finding and paragraph 6 of the final decision. Representatives of Kazakhstan participated in the meeting, making a presentation on the progress reports and answering questions from the branch.

10. The enforcement branch appreciated the progress made by Kazakhstan as provided in its progress reports and the comprehensive presentation made by the representatives from Kazakhstan at the meeting. The branch noted that it will look forward to receiving more information from Kazakhstan, which would be submitted in subsequent progress reports to be considered at its 38th session.

11. The enforcement branch requested its chairperson to write a letter to Kazakhstan inviting clarifications and additional information, including information on the questions of implementation that are directly linked to the acceptance and implementation of the Doha amendment (decision 1/CMP.8), to help its decision-making. The branch further requested the secretariat to provide advice on the questions of implementation with respect to Kazakhstan that are not dependent on its acceptance of the Doha Amendment.

5. Other matters

12. The branch authorized the chairperson and vice-chairperson to set the date for its 38^{th} meeting, taking into account the dates of the meeting of the plenary, which will be considered by the plenary at its 24^{th} meeting.





13. No other matters were raised.

6. Closure of the meeting
