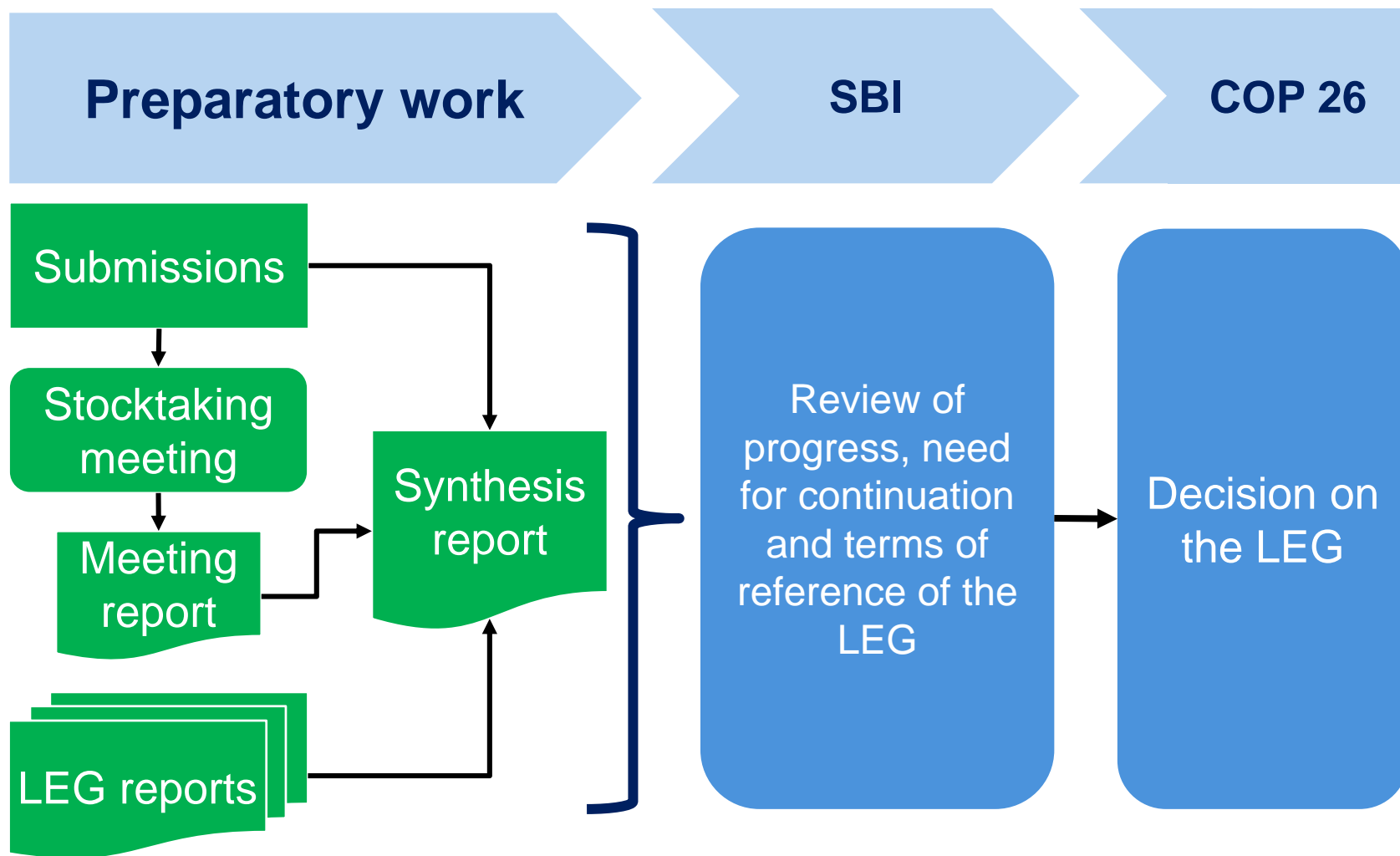

The **LDCS HAVE ACHIEVED MAJOR MILESTONES** as a result of the LEG modalities of support



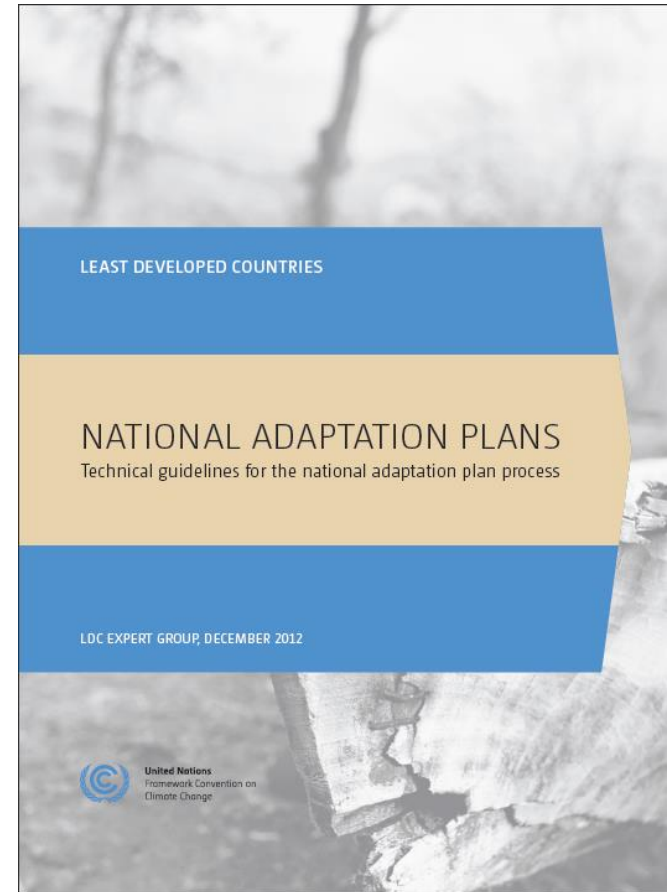
The needs of the LDCs cannot be fully met by the LEG alone. **COMPLEMENTARY ACTIVITIES** of other bodies and organizations are crucial;

Collaboration with others has allowed for effective coordination, alignment and delivery of support to the LDCs

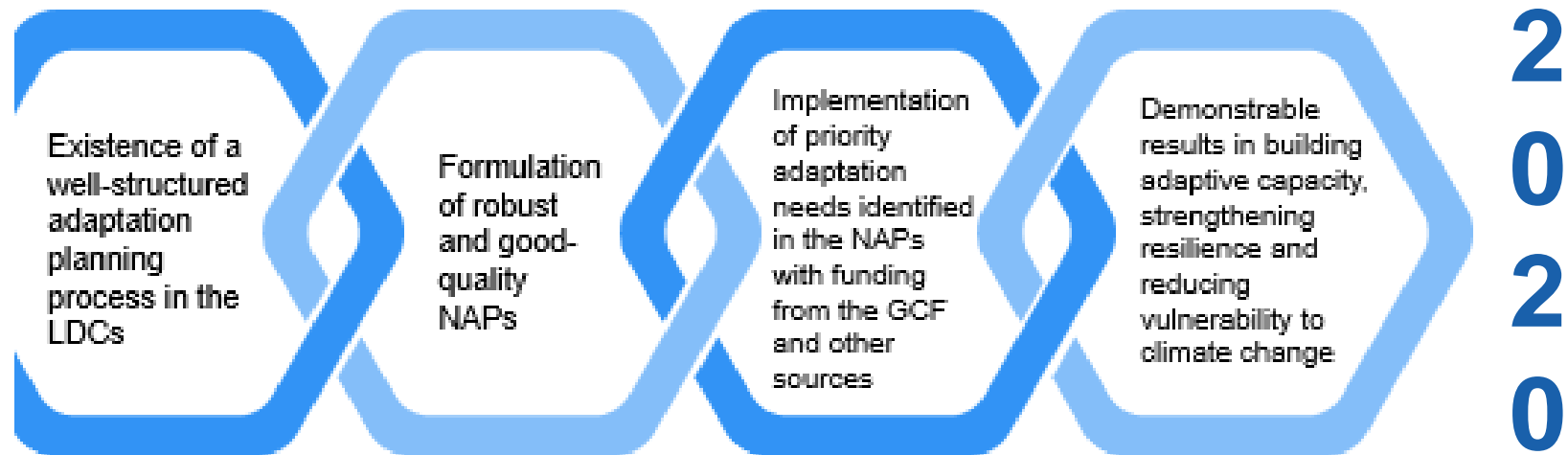

Outcomes of the LEG stocktaking meeting

- ❑ Adaptation-related elements of the LDC work programme
- ❑ Formulation and implementation of national adaptation plans
- ❑ Gender sensitivity; vulnerable groups, communities, ecosystems
- ❑ Facilitating dialogue on accessing funding: GCF, LDCF, AF
- ❑ Brokering support from other sources for implementation
- ❑ Identifying and addressing LDCs' specific gaps and needs
- ❑ Coherence and synergy between adaptation and related issues
- ❑ Mobilizing and engaging relevant bodies and a wide range of organizations



Outcomes of the LEG stocktaking meeting:

- Technical guidance and support
- Technical guidelines and supplements
- Technical papers
- Open NAPs and case studies
- Training workshops
- NAP Expos
- NAP Central and the NAP tracking tool
- Writing workshops and facilities for developing funding proposals

Outcomes of the LEG stocktaking meeting:

- Minimum of 5 years, or ideally 10 years to align with SDG timeline;
- Enhancing accessibility of technical materials, products, meetings and activities;
