

### 2024 OCEAN DIALOGUE

### Two dialogue topics chosen in consultation with Parties and Observers:

- 1. Marine biodiversity conservation and coastal resilience.
- 2. Technology needs for the ocean climate action, including finance links.
- 300+ case studies and good practices exchanged

# SELECTED KEY MESSAGES

#### TOPIC 1

 Conservation, protection, and restoration of coastal and ocean ecosystems, provide a wide range of ecosystem services and benefits.

 Marine Protected Areas support livelihoods, safeguard marine biodiversity, and increase climate resilience.

 Recognition of the pivotal role of Sustainable Ocean Plans, Integrated Coastal Zone Management and Marine Spatial Planning.

• Improved availability of and access to financing blue carbon ecosystems can enable accelerated climate action.

• Reaffirming the key messages on this Topic from the 2023 dialogue.

# SELECTED KEY MESSAGES

#### **TOPIC 2**

- A range of renewable ocean energies, and green shipping technologies can reduce carbon emissions, with low environmental impacts.
- Further research needed for marine carbon dioxide removal technologies.
- Satellite-based remote sensing technologies and automated ocean-based technologies can advance Parties' efforts to adapt to climate change impacts.
- Technology Needs Assessments can enable the identification, development and deployment of oceanbased technologies, and inform the development and implementation of NDCs.
- Finance and capacity building are critical enablers to accelerate technology related ocean climate action.

# SELECTED KEY MESSAGES

#### CROSS-CUTTING & FOR COP29

- Parties are encouraged to include ocean-based mitigation and adaptation measures in their NDCs and NAPs.
- Parties are encouraged to align their NDCs, NAPs, and NBSAPs.
- Strengthening partnerships and promoting cooperation can drive ocean-based climate action and enhance data accessibility.
- Constituted Bodies to continue integrating the ocean in relevant workplans and activities as per the Glasgow mandate.
- In the context of the **GST follow up**, Parties may consider submitting their views on ocean mandates contained in the GST decision.
- Parties may wish to consider how the negotiated outcomes on the finance mandates, can support the implementation of projects, case studies and priority areas identified in the ocean dialogue.
