Submission by EIG to SBSTA 15 Cooperation with other international organizations:

- Create a space for continuous discussions to enhance cooperation among the Rio Conventions and other international organization's conventions & frameworks. This should be done by keeping the SBSTA agenda item 15 open at every session.
- The continuous process set up should ensure substantive exchanges going beyond merely noting the Secretariate's report.
- The establishment of a process to come up with a set of recommendations on how to enhance cooperation and policy coherence among the Rio conventions and other relevant international organizations and frameworks. This could be by establishing a temporary group of technical experts nominated by parties and ensuring a regional balance or other similar arrangements taking into consideration available resources.
- The process should make use of existing mechanisms as far as possible, including the Joint Liaison Group (JLG) which already has mandates from the CBD and the UNCCD to enhance cooperation and explore options for a joint work programme.

Submission by Colombia:

Elements for a Draft Decision on Agenda Item 15: Cooperation with other international organizations

Context and Rationale

Colombia supports ensuring that this agenda item serves as a space for having substantive discussions on how to strengthen international cooperation with other organizations for the implementation of the Convention and the Paris Agreement, including — and particularly — the cooperation among the three Rio Conventions. Colombia, as current President of the CBD COP16, attaches particular importance to strengthening the international cooperation among the three Rio Conventions — the UNFCCC, the CBD, and the UNCCD — recognizing that climate change, biodiversity loss, and desertification are interconnected challenges requiring coherent and mutually supportive responses.

Recent decisions under the CBD and UNCCD, including CBD Decisions 15/4 and 16/22 and UNCCD Decision 8/COP.16, call for enhanced cooperation among the Rio Conventions and provide a solid basis for complementary, non-prescriptive efforts under the UNFCCC. Colombia believes the UNFCCC can build on these mandates and collaborate with the COP Presidencies of the CBD

and the UNCCD to foster coherence while fully respecting the mandates and institutional structures of each Convention.

Objective

The expected outcome for Colombia at this COP is a decision that elevates this agenda item from being primarily procedural to one that enables substantive discussions and substantive recommendations on how to advance cooperation with other international organizations.

Colombia's Key elements for a draft decision on Item 15

Colombia considers that a balanced, non-prescriptive COP decision should include:

- Maintaining the SBSTA agenda item open at every session, allowing continuous and constructive discussions on cooperation with international organizations.
- Enabling substantive exchanges under this agenda item, moving beyond merely noting a Secretariat report towards generating substantive recommendations on cooperation for implementation, including and particularly among the Rio Conventions.
- Establishing a limited, time-bound, and targeted expert process, with regional balance, with
 modalities subject to the availability of resources, to identify recommendations for
 enhancing international cooperation for the implementation of the Convention and the Paris
 Agreement.
- Ensuring that this process is guided by a people-centered approach, has a facilitative and
 non-prescriptive nature, respects the individual mandates of each Convention,
 acknowledges the existing gap between available and required resources to meet the goals
 of the three Rio Conventions, and safeguards the institutional integrity of each Convention
 and its Secretariat.
- Building on existing mechanisms, rather than creating new ones, particularly by strengthening the Joint Liaison Group (JLG) to enhance collaboration among the secretariats of the Rio Conventions. The JLG already operates under mandates from the CBD and UNCCD to enhance cooperation and explore options for a joint work programme. Under the UNFCCC, this would mean aligning with and contributing to those existing mandates agreed by consensus, while ensuring that the institutional arrangements, mandates, and secretariats of each Convention remain distinct.

EU submission on SBSTA item 15 – Cooperation with other International Organizations:

As EU we would suggest the following bullet points as a structure for the proposed text by the SBSTA chair on this item.

- SBSTA concludes that Parties agreed to use SBSTA item 15 on 'Cooperation with other International Organizations' for substantive discussions, moving beyond taking note of the annual report by the secretariat on cooperative activities. This substantial work is to be seen in the context of implementing the outcomes of the first Global Stocktake for achieving the goals of the Paris Agreement. The item should be a recurrent item on the SBSTA agenda.
- The item should provide for information sessions with involvement of the relevant international organizations to allow discussion with Parties and Observers on how to strengthen international cooperation. The annual report of the UNFCCC secretariat on cooperative activities can serve as a basis. The scope of the discussion should be similar to the report and hence potentially cover the full range of cooperative activities.
- The discussion should particularly have the purpose of exchanging information, sharing
 good practices, including at national and subnational level, and lessons learned and
 exploring how to strengthen international cooperation with the different international
 organizations.
- The SBSTA should recognize the need for further technical work.

- Regarding synergies among Rio Conventions, the Paris Agreement and other Multilateral Environmental Agreements, SBSTA should work on guidance towards the secretariat, particularly on:
 - Strengthening the Joint Liaison Group including by increasing its transparency and its engagement with and reporting to Parties
 - Ontributing to technical information exchanges organized by the Rio convention secretariats to strengthen cooperation on areas such as science, integrated approaches at the national and subnational level, issues on transparency, finance and advancing gender equality and human rights, and the role of Indigenous Peoples as well as local communities.

- 4. Consider improved modalities of work, including scope and activities, with a view to ensuring more substantive discussions capable of providing practical and strategic guidance for cooperation actions.
- 5. Provide additional space for substantive work under this agenda item.
- 6. Include recommendations on priority areas where cooperation actions and efforts need to be strengthened.
- 7. Support increased and enhanced engagement among the three Rio Conventions Secretariats—CBD, UNFCCC and UNCCD—including strengthened roles and functions of the Joint Liaison Group.
