# **CLIMATE LAW AND GOVERNANCE INITIATIVE**

### Climate Law & Governance Initiative Offers Events, Public Engagement Opportunities to Delegates and Public at COP23

The <u>Climate Law & Governance Initiative (CLGI)</u> will offer several events and public engagement opportunities at COP23. Two of the events—the <u>3rd Annual Climate Law &</u> <u>Governance Day</u> and the <u>Climate Law & Governance Specialisation Course</u>—will take place outside of the Bonn Zone, and therefore will NOT require UNFCCC accreditation, but DO require pre-registration; both events have been endorsed by the COP22 and COP23 Presidencies.

Other events include the 'Centre for International Sustainable Development Law (CISDL) & COP22 Presidency Panel: Implementing the Paris Agreement in the Context of Sustainable Development' on the 13 November in the DIE Interconnections Zone, and the 'CISDL & London School of Economics (LSE) Official UNFCCC Side Event: Advances in Climate Law and Governance - Implementing the Paris Agreement Worldwide' on the 16 November in the Bonn Zone. CLGI also welcomes conference attendees to visit its exhibit booth (shared with CISDL) in the Bonn Zone, which features working papers, articles, manuals, and other information from its partners on key climate law and governance issues. **More information on all events is found below, following this release (pages 2-3).** 

Programming will be centered on the law and governance elements of implementing the Paris Agreement and Sustainable Development Goal 13 amidst the complexities of actors (including nations, as well as subnational and non-state actors) involved. Events are targeted at government delegates, non-state and subnational representatives, law and governance scholars and students, and climate leaders from civil society and the private sector.

This marks the third subsequent year CLGI has offered formal capacity-building and knowledgesharing engagement opportunities at UNFCCC COP conferences, having also engaged via its core partners such as CISDL, the Centre for International Governance Innovation, and the Lauterpacht Centre for International Law at the University of Cambridge, since Montreal in 2005. CLGI has hosted several events in the interim, and offers a knowledge center including working papers, blog posts, and articles on climate change law and governance on its <u>website</u>.

CLGI looks forward to welcoming a diverse set of actors to its programming and exhibit booth at COP23 thanks to our growing partnership of academic research centres, IGOs, law firms, and think tanks.
