Concept Note

Background

The latest version of the NDC synthesis report released before COP27 found that the taking into account current commitments in Parties' submitted NDCs will increase emissions by 10.6 per cent by 2030, compared to 2010 levels, as an improvement from last year's assessment. With regards to projected emissions beyond 2030, this year's analysis shows that while emissions are no longer increasing after 2030, they are still not demonstrating the rapid downward trend science says is necessary this decade. The recently released IPCC Ar6 Synthesis Report, confirms the urgency of ambition and action from the increasing diversity of Actors involved in Climate Action and outlines the cost of inaction.

The Conference of the Parties serving as the meeting of the Parties to the Paris Agreement (CMA) at its fourth session in Sharm el-Sheikh urged Parties that have not yet communicated new or updated NDCs to do so as soon as possible in advance of its fifth session¹ and requested Parties to revisit and strengthen the 2030 targets in their nationally determined contributions (NDCs) as necessary to align with the Paris Agreement temperature goal by the end of 2023, taking into account different national circumstances.²

The CMA at its fourth session additionally urged Parties that have not yet done so to communicate, by CMA 5, long-term low GHG emission development strategies (LT-LEDS) towards just transitions to net zero emissions by or around mid-century, taking into account different national circumstances.³ The CMA also invited Parties to update their LT-LEDS regularly, as appropriate, in line with the best available science and noted the importance of aligning nationally determined contributions with LT-LEDS.⁴

On the 18th of April, the UNFCCC secretariat sent a notification to Parties informing them about the important dates and approaches for the NDC Synthesis Report and LT-LEDS Synthesis Report in 2023. The secretariat is planning to publish the 2023 version of the NDC and LT-LEDS synthesis reports by 14 November 2023, updated on the basis of the latest NDCs and LT-LEDS that have been communicated by 25 September 2023.

Objective
