ABOUT THE AWARD

Launched in 2015, by the WGC, the Gender Just Climate Solutions Award honours the fundamental contribution of women in the fight against climate change and demonstrates the pertinence of integrating gender equality in all climate policies. Women are still underrepresented in consultation and decision bodies at local level, only 20% of councillors and just 5% of mayors globally are women according to UCLG*. At the national or international level, women are still largely a minority in UNFCCC bodies, mechanisms, and delegations. The award highlights technical solutions, training or awareness-raising, and transformational solutions that encourage sharing of best practices. It also inspires politicians and financers to develop more effective and fairer climate strategies.

WINNER CATEGORIES

- Technical Climate Solutions with a women's rights or gender equality perspective (e.g. in area of renewables, water-saving adaptation technologies)
- Non-Technical Climate Solutions with a women's rights or gender perspective (e.g. in area of efficiency, consumption changes)
- Transformational Climate Initiatives with a women's rights or gender perspective (e.g. addressing governance, institutional change, planning processes)

HOW TO APPLY

- Who all types of activist, grassroots and women-led organizations and groups working on issues related to climate change are encouraged to apply. Local or national government initiatives cannot apply.
- What the activity/initiative must focus on finding solutions to cope with climate change as well as integrate gender equality as a central component.
- When you can apply each year between end of June and beginning of September.

Each winner will receive a seed grant of 2,000 Euros.

BETTER WORLD CAMEROON

Cameroon - BWC offers a simple, low cost, sustainable alternative to heavy use of solid fuel by building clean cookstoves with mud-building techniques and local materials.

The main objectives of this participatory project are to: improve the livelihood of women by training them on the construction of low-emitting mud cookstoves, reduce air pollution, improve health, and enhance women's participation in community engagement. Reaching 300 beneficiaries in 30 communities, BWC has held 10 participatory stove building workshops

with women's groups; held training of trainers; supported the establishment of partnerships and cooperatives to foster income generation; organized annual meetings for all trainees.

NAVDANYA & SOL

India & France - The project "Seeds for Hope" improves the climate resilience, food sovereignty and economic autonomy of farming communities (20,000 people) in the valley of Derhadun, in Northern India, relying on women's knowledge and action. They are trained to reproduce and conserve local seeds, learn agro-ecological techniques and food transformation, which reinforces their power to make decisions. The project is led in partnership with the association Navdanya, created by Vandana Shiva. Direct beneficiaries: 745 farmers and their families in 31 villages.

LAO PDR - GDA assessed gender roles in the northern rural uplands of Lao PDR, focusing on Non-Timber Forest

atically marginalized in Lao PDR. The project identified key areas and documented policies for improving sustainability. Women leaders in the community participated in the Training of Trainer workshops with the goal to enhance their capacity and their knowledge sharing.

THE KICKOFF OF SOMETHING GREAT!

Winners from previous years have already up-scaled their projects with the help of their award grant. For example, Enda Graf Sahel, 2016 transformational winner, bought 45 efficient cookstoves for Simal, Nadagane Sambou and Djilor villages. With this equipment, shellfish processing becomes more sustainable as households have a smaller use of wood.

Follow-up workshop on scalability

The Climate Technology Centre & Network (CTCN) is inviting all the winners from 2017, 2016 and 2015 to a workshop on "Up-scaling gender-just climate solutions: sharing on climate technology and finance", at LVR-Landesmuseum, November 15. WECF, WGC and CTCN's climate experts will mentor the winners on how to scale-up their gender just climate projects and about integrating them into national climate strategies. The aim of the workshop is to build capacity and share knowledge on how to overcome financial, technical, communicative and advocacy challenges.



When gender is effectively integrated into climate change initiatives, the outcomes are more impactful, equitable and sustainable. Through this transformative workshop, the WGC and CTCN will share technological, finance and advocacy insight into up-scaling gender-responsive implementation of the Paris Agreement.

NO CLIMATE JUSTICE WITHOUT GENDER JUSTICE

Many efficient solutions implemented by women are often overlooked by decision-makers who instead prioritize technical solutions and expensive projects meant to leave a big impression. Not everyone is affected in the same way by climate change, which became clear this summer during the natural disasters taking place around the world, i.e. Sierra Leone, Mexico, US, and Puerto Rico.To ensure the longevity of climate actions; projects and policies must respond to the actual needs of people. These needs differ depending on your gender role in society, class, race, whether you live in the Global South/North or rural/urban.

Strengthening the resilience of territories and populations confronted with climate change is crucial. Women are often the ones preserving traditional knowledge and responding to their communities' and territories' needs by contributing to adaptation and mitigation strategies. Women are initiating renewable energy cooperatives in Georgia, decolonizing agriculture and preserving biodiversity with seed banks in India and the Ivory Coast, fighting against deforestation in Malaysia, pushing for innovate agriculture by improving soil fertility in Nepal. Their local success stories could be up scaled and replicated if they were correctly honoured, taken into account by international orientations and were financed by climate funds.



BRIEF HISTORY

Women in climate negotiations

The first decisions relating to gender equality and participation of women was taken in 2001. In Bali, 2010, the Parties adopted several decisions integrating a gender dimension in finance, adaptation and capacity building. Sending out a strong message that for effective climate actions. we must ensure gender equality and participation of women. The Parties, supported by CSOs and UN agencies, have since then included gender equality considerations in nearly all thematic areas of the adopted UNECCC decisions. This includes the notable Doha decision 23/CP.18 in 2012 linked to parity and participation for women: the launch of the Lima Work Programme on Gender (LWPG); the preamble of the Paris Agreement and its articles 7 and 11 on adaptation and capacity building; the decision 21/CP.22 on awareness-raising and on further capacity-building.

Despite all these decisions, gender inequalities, often reinforced by climate change impacts, are rarely and poorly evaluated and the specific needs of women remain to be considered insufficiently in the elaboration, the planning and the financing of climate policies.

Adopt a robust GAP

a comprehensive, targeted and resourced two-year gender action plan (GAP) as a critical outcome for COP23, in order to urgently advance gender-responsive and human-rights based climate policy and action. The GAP must be an instrument that effectively supports the overall goal of an urgent transition from a deeply unjust fossil-fuel based economy to a more sustainable, just and equitable model of development that ensures women's human rights and gender equality.

Our demands for the GAP

- Step-change in implementation of gender-responsive climate policy development, delivery and reporting at national level, particularly via gender budgeting in climate programming.
- Increased availability of sex and gender disaggregated data and analysis (including data based on local and traditional knowledge, including women's traditional knowledge).
- Meeting the goal of gender balance in in all aspects of climate change policy-making, on delegations, boards and bodies of the UNFCCC as well as at regional and national level, and ensuring the full and effective participation of local, grassroots and indigenous women in these spaces.
- A goal of 100% gender-responsive climate finance and other means of implementation, including ensuring environmentally and socially sound technology transfer and development.
- Financing the gender action plan The WGC stresses that developed country Governments must urgently commit resources to the specific activities indicated under the GAP, both ensuring necessary resources for the UNFCCC gender focal points and prioritizing gender-related climate activities in major funding initiatives and plans.
