With the successful completion of the third review of the Warsaw International Mechanism for Loss and Damage associated with the adverse effects of climate change (WIM), the decision adopted at COP 30 reinforces the WIM’s role in supporting developing countries. Through its thematic expert groups, the WIM Executive Committee has generated a growing body of knowledge on these issues. The session will also explore the specific challenges that vulnerable countries and communities must anticipate and manage as impacts intensify, and focus on ways in which the WIM can strengthen the practical application and accessibility of this knowledge, and support countries in navigating available resources and implementation support.</p>
<ul style="list-style-type: none"> Delivering AI for Climate Action in Developing Countries 	<p>Artificial intelligence is rapidly emerging as a transformative enabler of climate action, offering practical applications, for example in early warning systems, climate modelling, precision agriculture, energy optimization and disaster risk reduction. The UNFCCC Technology Mechanism AI for Climate Action Initiative advances the understanding of opportunities, risks and challenges of AI-driven climate solutions. Supported by the Korea International Cooperation Agency (KOICA) through the UNFCCC-KOICA Climate Future Partnership, the Initiative promotes locally led innovation, strengthens capacities and facilitates knowledge exchange to accelerate climate change mitigation and adaptation action in developing countries, particularly LDCs and SIDS.</p>
<ul style="list-style-type: none"> From Local Action to Global Impact: How Subnational and Local Governments Drive Just and Inclusive Climate Ambition and Implementation through Action for Climate Empowerment 	<p>Subnational and local governments play a critical role in translating global climate goals into tangible action on the ground. Bringing together policymakers, practitioners, and partners across levels of governance, this open event will explore how cities and regions can advance climate ambition and implementation by integrating the six Action for Climate Empowerment (ACE) elements – climate change education, public awareness, training, public participation, public access to information and international cooperation – in their efforts to deliver just and inclusive transitions.
