



#Together4Transparency Opening High-Level Event:

Celebrating the Transparency Journey

12 November 2024, 17:00 – 19:00 Venue: Shirvan Special Room, Zone B, COP29, Baku

Background

Transparency builds trust and lays the foundation for ambitious climate action by helping to track successes in climate action and identifying areas for improvement and keeping us on the path to limiting global warming to 1.5 degrees Celsius.

The enhanced transparency framework (ETF) of the Paris Agreement requires countries to submit the first biennial transparency reports (BTRs) by the end of 2024 and every two years thereafter. The BTRs will be a primary vehicle for Parties to demonstrate the progress of implementation of the Paris Agreement. Broadly speaking, the ETF is already in operation as few Parties have started submitting their BTRs and the technical expert reviews were conducted. Many Parties are making the last efforts and final preparations to ensure they can submit their BTR by the stipulated deadline of 31 December 2024.

Support is available all along the way, and UN Climate Change, together with the COP29 Presidency and support providers, is working overtime to provide a range of practical supports, with a view to ensuring that all countries can effectively participate in the ETF. Moreover, the COP29 Presidency has launched **the Baku Global Climate Transparency Platform (BTP)** to enable the delivery of BTRs in 2024 and serve as a platform for targeted support for the ETF implementation.

To ensure universal participation in the ETF and to support the full implementation of the Paris Agreement, all stakeholders must be involved, and collaboration is essential between Parties and Non-Party stakeholders. Everyone has a role in working #Together4Transparency.

Objectives

This HL event will aim to:

- Celebrate and recognize the effort of the frontrunners who have already submitted the 1st BTRs;
- Generate strong momentum for the timely submission of the BTRs and the universal participation in the ETF;
- Show that the ETF is operational;
- Showcase the importance of climate transparency for all stakeholders committed to implementing the ETF such as cities regions and corporations.
