COP 24 Climate Change Conference participants are invited to the mandated COP event Global Climate Action (GCA) High-Level Event with the participation of the Prime Minister of the Republic of Poland and the Secretary-General of the United Nations and other leaders. The GCA High-Level Event will offer a unique vision of how the world is affected by climate change and how different sectors are tackling the issue. It will highlight collaboration, synergies and progress between Global Climate Action stakeholders.

The high-level event led by the Secretary-General of the United Nations, Mr. António Guterres and the Prime Minister of the Republic of Poland, H.E. Mr. Mateusz Morawiecki will introduce the declaration “Driving Change Together – Katowice Partnership for E-Mobility”, proposed jointly by Poland and the UK. The COP 24 President Michał Kurtyka, together with partnering governments and sub-national authorities, as well as businesses and NGOs will launch a dedicated framework for the partnership and discuss the benefits of e-mobility for climate and the global economy.

The IPCC, in response to the invitation by COP 21, has made available a special report entitled: “Global Warming of 1.5°C, an IPCC special report on the impacts of global warming of 1.5°C above pre-industrial levels and related global greenhouse gas emission pathways, in the context of strengthening the global response to the threat of climate change, sustainable development, and efforts to eradicate poverty.” It was adopted at IPCC 48 (Incheon, 1-5 October 2018).

The event will introduce to Parties the new scientific concepts and definitions used in the report. It will focus on the key findings of the report, including on the impacts of 1.5°C, structured in line with the Summary for Policy Makers (SPM).
