Demonstration on Saturday, 8 December

A protest march will take place at various locations in Katowice from 12.00 to 16.00 hrs. on Saturday, 8 December. It is anticipated that at approximately 13.00 hrs., 4,000 marchers will pass by the front of the main gate to the COP 24 venue, where a noisy demonstration will take place for about 30 minutes. The demonstration is expected to include many different groups with the common message of "Wake up, March for Climate Change." The marchers will be kept approximately 50m away from the venue on the opposite side of the street. Polish authorities do not anticipate any traffic disruptions; however, it is advised that the area of the front main entrance should be avoided from 13.00 to 14.00 hrs. due to potential overcrowding.

Closure of the venue on Sunday, 9 December



The COP 24 venue will be closed on Sunday, 9 December. No official meetings will take place and no deliveries will be permitted. The main entrance will be closed, but limited entry for media and technical staff will be permitted at the secondary entrance in Building H. Parties with office space also will be permitted limited entry based upon the list provided by UNFCCC Conference Affairs Services.
