Opening of the second part of the high-level segment

The opening of the second part of the high-level segment of COP 24/CMP 14/CMA 1.3 will take place in Plenary Mazowsze today at 15.00 hrs. The opening will be presided over by Mr. Michał Kurtyka, President of COP 24/CMP 14/CMA 1.3, and will be attended by His Excellency Mr. Henryk Kowalczyk, Minister of Environment of Poland, Mr. Petteri Taalas, Secretary-General of the World Meteorological Organization, Mr. Hoesung Lee, Chair of the Intergovernmental Panel on Climate Change and Ms. Patricia Espinosa, UNFCCC Executive Secretary.

Participants are asked to take their seats in Plenary Mazowsze by 14.30 hrs. to ensure that the opening can begin promptly.

Statements at the opening of the second part of the high-level segment will be delivered by the President of COP 24/CMP 14/CMA 1.3, the Minister of Environment of Poland, the Secretary-General of the World Meteorological Organization, the Chair of the Intergovernmental Panel on Climate Change and the UNFCCC Executive Secretary.

At approximately 16.00 hrs. the conference will begin hearing national statements and statements on behalf of groups.

The second part of the high-level segment will continue on Wednesday, 12 December at 10.00 hrs. in Plenary Mazowsze to continue with national statements. Owing to the number of Parties who have registered their request to deliver a national statement, and the limited amount of time available **national statements on Wednesday, 12 December will be on-going without a break.**

Statements by intergovernmental organizations, followed by statements from non-governmental organizations are scheduled to be taken up after the completion of national statements. The statements of IGOs will be taken up in alphabetical order by organization's name.

The high-level segment will conclude on Wednesday, 12 December.

Special passes will be required for access and attendance at the opening of the resumed high-level segment in Plenary Mazowsze. These special passes can be collected at the Information Desk of the conference venue.

Today, over 258 million migrants live outside their country of origin across the world and climate change is expected to increase this number.

Climate impacts that affect large movements of people include increasingly long heatwaves, droughts or sea-level rise that make land uninhabitable.

At the COP, countries have been working on a set of recommendations that will help countries cope with the displacement of people as a result of climate change. Concurrently, countries adopted the global migration pact - Global Compact for Safe, Orderly and Regular Migration (GCM) - in Marrakech, Morocco on 10 December 2018.

The documentary, produced by Mr. Thomas Aders for ARTE TV will be screened on occasion of these two decisive steps towards bettering the situation of migrants. The screening will be preceded by brief remarks by both Mr. Aders and UNFCCC Deputy Executive Secretary, Mr. Ovais Sarmad.
