Continuation of Statements at the Resumed high-level segment

The resumed high-level segment of COP 27/CMP 17/CMA 4, will continue hearing statements from Intergovernmental organizations and groups of non-Governmental organizations admitted by the Conference of the Parties today, Wednesday, 16 November 2022 in **Plenary Nefertiti**, beginning at 10.00 hrs.

Access to Plenary Nefertiti for the continuation of statements at the resumed high-level segment is open to all participants. No tickets are required for attendance.

Please be advised that security and fire regulations do not permit participants to stand and security will enforce this requirement.

The proceedings can be followed on [webcast](#) and on the TV screens throughout the Conference Center.

Registered observer speakers are reminded that they are in the plenary at the start of the session for observer statements. Statements should not exceed the two-minute limit. To be fair to all speakers, time limits will be strictly enforced. **An electronic/mechanical device will be used to mark the 2 minutes allotted to each speaker.** This will allow **all** speakers to deliver their statements.

Representatives whose full texts exceed the time limit may wish to deliver a shortened version in plenary; the full text of all statements delivered during the resumed high-level segment will be uploaded and made available on the UNFCCC website. Hard copies of the full texts of the official statements will not be circulated in plenary during the resumed high-level segment. To have statements posted on the UNFCCC website, Representatives speaking at the resumed high-level segment are requested to e-mail an electronic copy of the statement to cool@unfccc.int.
