Second Plan of Action of the Action and Support Expert Group for Sep/October 2026– Sep/October 2028

The table below sets out the plan of action of the Action and Support Expert Groups, covering *Sep/Oct 2026 to Sep/Oct 2028*, which identifies the work of the expert group that will contribute to the implementation of the work of the Executive Committee related to enhancing action and support, including finance, technology and capacity-building, to address loss and damage associated with the adverse effects of climate change, including by maximizing synergies among relevant stakeholders and processes. The expert group will review progress in implementing this plan of action at its regular meetings and update the plan of action as needed, including working with experts as needed to refine deliverables and knowledge products (*this could be an additional ASEG decision point*).
