Background note

I. Background

1. As per activity 4 of the workplan of the forum and its KCI for the fifty-second to sixtythird sessions of the subsidiary bodies), the Katowice Committee of Impacts (KCI) is to enhance the capacity and understanding of Parties, through collaboration and input from stakeholders, on the assessment and analysis of the impacts of the implementation of response measures to facilitate the undertaking of economic diversification and transformation and just transition. The activity is to be implemented at its meeting taking place in conjunction with SB 52 and SB 63.

- 2. The KCI is to take inputs from experts, practitioners and relevant organisations.
- 3. The final output of this activity is a technical paper.

II. Scope of the note

4. This background note contains in its annex the draft outline of the technical paper to Enhance the capacity and understanding of Parties, through collaboration and input from stakeholders, on the assessment and analysis of the impacts of the implementation of response measures to facilitate the undertaking of economic diversification and transformation and just transition.

Draft outline for the technical paper

1. Introduction.

(iv) Identify possible actions and means to enhance capacity and understanding of Parties including collaboration with identified organisations in the areas of assessment and analysis of the impacts of the implementation of response measures to facilitate the undertaking of economic diversification and transformation and just transition.
