## Co-chairs' Elements paper for item 8 (version 9 Sep 19:00 CEST)

*On the basis of the work it has undertaken, the Executive Committee agreed to forward the following recommendations. Parties may wish to:*

## Welcome...

- a) The continued progress of the Executive Committee in implementing its five-year rolling workplan and that of its thematic expert groups in implementing their plans of action, including in response to the relevant outcomes of the 2019 Review of the WIM, despite the extraordinary challenges faced in 2021 due to the COVID-19 pandemic;
- b) The ExCom's adoption of the plans of action of the NELs EG, SOEs EG and ASEG;

## Expression of appreciation ...

- c) Heightened intersessional virtual work by the ExCom to ensure the progress of work while recognizing the associated challenges, including the ability to participate effectively due to internet connectivity;
- d) To all organizations and experts that contributed to the success of the work undertaken and to the constituted bodies that collaborated with the ExCom;
- e) To the secretariat for its support to the ExCom and the EGs
- f) Organizations that have submitted information to the ExCom on the technical assistance they are providing relevant to the Santiago Network in response to Decision 2/CMA.2, para 44 and Decision 2/CP.25;

## Urgency of action

- g) Note the increasing urgency of enhancing efforts on a.m.a. L&D as illustrated by findings of the latest scientific assessment reports;<sup>1</sup>

## Encouragement, urging, request to the ExCom and/or the EGs

- h) ExCom and expert groups to continue to use best available science to inform their work
- i) For the ExCom to continue to collaborate with constituted bodies and relevant organizations that are undertaking efforts relevant to a.m.a. L&D, with a view to enhancing synergies;
- j) For the ExCom to continue exploring further opportunities and modalities to engage national-level stakeholders, including the UNFCCC National Focal Points and Loss and Damage Contact points;
- k) For the expert groups to continue enhancing synergies in implementing their PoAs;
- l) For the ExCom to have its rolling workplan updated during the course of 2022;
