# Summary of Decision Points

## Item 2: Adoption of the agenda

Excom adopted agenda as contained in the document Excom/2020/12/1

Item 3: Launching of the expert groups on slow onset events, non-economic losses, and an expert group pursuant to decision 2/CP.19, paragraph 5(c).

- Excom adopted the terms of reference for the expert groups on slow onset events, non-economic losses, and action and support as available on the Excom 12 webpage.
- Excom elected the following members to serve in the newly launched expert groups:
  - Slow onset events: Antonio Cañas, Imran Khan, and Malcolm Ridout [with second A1 member to be confirmed before end of this week]
  - Non-economic losses: Adao Soares Barbosa, Jerome Ilagan, Kajsa Fernström Nåtby and Valeriy Sedyakin
  - Action and Support: Alpha Kaloga, Dawn Pierre-Nathoniel, Farhan Akhtar and Jelena Milos
- Excom confirmed the general timeframe as follows:
  - Excom members of the respective new groups to finalize and send to the co-chairs for endorsement, a list of technical experts to be invited to serve in respective expert groups by 12 November.
  - In parallel, the Excom members of the expert groups to decide on the timing or date of the 1<sup>st</sup> meeting of the respective expert groups.
  - The secretariat:
    - To send invitations to experts to serve on the expert groups by the end of November to first week of December, including information on the 1<sup>st</sup> meeting if already available.
    - To update information on the expert groups and the WIM Roster of Experts on the Excom webpages.

## Item 4: Development of technical guides

- Excom took note of ideas on the general approach introduced by the co-chairs in their presentation and expanded on general principles and next steps, in particular:
  - Expert groups will discuss ideas and topics for technical guides and present preliminary outlines bearing in mind the mandate as contained in decision 2/CMA.2 and communicate proposal(s) to the Excom.
- Once proposals are received by the Excom, the Excom will consider whether to endorse the
  topics and outlines, taking into account their ability to promote collaboration and coherence of
  work across expert groups, and as soon as is practical to inform the PoAs of the expert groups.
  - o The associated work will become part of the Plan of Action of each group involved.
  - o Final draft guides would then be cleared by the Excom before final release.
- The Excom noted that, at its first meeting of the year, in future years, the Excom will prioritize
  discussion of activities in thematic areas of work to promote collaboration across the expert
  groups.

# Item 5: The role and contribution of the Excom in the global stocktake as contained in decision 19/CMA.1

- Excom established an intersessional group of champions to discuss preparing a draft table of
  contents of the synthesis report for consideration by the Excom at its next meeting, taking into
  account initial views shared during Excom 12 on the possible scope of information in response
  to para 36(e) of decision 19/CMA.1, indicative timeframe and milestones as well as ways to
  liaise with other constituted bodies.
  - The intersessional group of champions: Antonio, Farhan, Kajsa and Le-Anne.

- b) The publication of a policy brief, jointly with the TEC, on technologies for averting, minimizing and addressing loss and damage in coastal zones<sup>1</sup>;
- c) The work of the Excom in initiating the implementation of the relevant outcomes of the 2019 Review of the WIM, in particular, the adoption of the TORs of the expert groups on slow onset events, non-economic losses and action and support;

Expression of appreciation ... Parties may wish to express appreciation:

d) To all organizations and experts that contributed to the success of the work undertaken, and to the constituted bodies that collaborated with the Excom;  $(para\ 18\ (d)(i)^2)$ 

Noting ... Parties may wish to note:

- e) The progress made by the Excom in discussing the response to the invitation from the CMA to prepare a synthesis report for the technical phase of the global stocktake;
- f) The importance of having the Excom and its expert groups draw upon relevant information from a broad range of sources, including reports submitted by Parties.

g) Recognize the decision of the Excom to continue exploring further opportunities and modalities to engage national level stakeholders, including the UNFCCC National Focal Points and Loss and Damage Contact Points.

# Inclusion in the non-recommendations section of the report:

Challenges experienced and lessons learned in not being able to pursue 'BAU' modalities of work (e.g. in-person meetings) during the reporting period due to the COVID-19 pandemic, including how the Excom may use virtual meetings to continue to further improve its working modalities for intersessional work.

- Ways in which the COVID-19 pandemic has highlighted the interaction and the
  interconnectedness of multiple risks (e.g., health, climate change) as manifested in cascading
  impacts on vulnerable communities and countries as discussed and captured in the summary
  of TEG-CRM 2, held 7 July 2020.
