Progress of PDD-led activities under TFD Plan of Action 2019-2021

Activity 5: Prepare a technical briefing on approaches to averting, minimizing and addressing loss and damage in relation to disaster displacement

<u>Update March 2020</u>: This activity is included in the PDD Workplan 2019 under Chapter I.4.C: Prepare a technical briefing paper on loss and damage approaches to disaster displacement and present/submit to WIM for consideration and inclusion in its report to the COP(s). Funding has been allocated and the plan is to finalize the paper in 2021 for submission and consideration by WIM and at COP 27.

Activity 18: Support the inclusion of the challenges of displacement related to the adverse effects of climate change in the work of the high-level panel on internal displacement

<u>Update March 2020:</u> A regional and thematic meeting on 'Managing Risk and Addressing Disaster Displacement: Challenges, Effective Practices and Solutions in the Asia Pacific and Beyond - Regional and Thematic Consultation on Disaster Displacement for the High-Level Panel on Internal Displacement' is being planned for in Bangkok first week of June 2020 (originally scheduled for 20-21 April 2020 but the meeting had to be pushed back due to risks associated with COVID-19). The Consultation will be organized jointly by the High-Level Panel on Internal Displacement Secretariat, the GP20 Initiative on internal displacement, the Platform on Disaster Displacement (PDD), and the Asia-Pacific Disaster Displacement Working Group in Bangkok, Thailand (convened by UNDRRR and IOM), with generous funding from the Swiss Federal Government and the Government of Sweden. A Background Paper on Disaster Displacement, including with a focus on the Asia-Pacific region will also be prepared and drafted the Consultation. It will aim to present 'a state of the' art regarding disaster displacement, an overview of existing policy and normative frameworks, sample of effective practices and a non-exhaustive list of the most important: 1) knowledge and data gaps; 2) legal and policy gaps; 2) institutional and operational gaps; and 3) funding and financial mechanisms gaps.

Activity 2: (with Advisory Group Civil Society Organisations (IDMC)) Prepare TFD factsheets providing an annual overview of global disaster displacement: gender-disaggregated data, analysis by region, livelihood and income group, and hazard context.

Activity 14: (with IOM, Norwegian Refugee Council) Support Parties in integrating displacement risk into DRR strategies and combining action on DRR and climate change

Activity 15: (*with IFRC, UNHCR*) Support Parties in strengthening their understanding of preparedness for displacement related to the adverse impacts of climate change, including early warning systems, contingency planning, evacuation planning and resilience-building strategies and plans, and support them in developing innovative approaches to preparedness, for example forecast-based financing
