











Sharing Experiences in the Inclusion of NDCs in Sub-national Territorial Planning Concept Note

Background

Grupo FARO is an Ecuadorian think tank that generates evidence to influence public policy and promotes best practices for social transformation and innovation. Our organization was created in 2004 as an independent, plural and non-partisan nonprofit organization that conducts research and implements innovative projects to build a more equitable society. We seek to become a regional model of innovation that promotes social cohesion in Ecuador and Latin America. We have a multidisciplinary team that focuses on generating evidence, fostering collaborative action, and implementing initiatives in the following areas: Democracy, Transparency and Active Citizenship; Sustainable Development and Cities; Research and Evaluation of Public Policies and Programs; and, Education.

The success of the Paris Agreement signed in 2015, depends entirely on the goals that the Parties shape through the National Determined Contributions (NDC). The subnational governments have a major role in the construction and specially in the implementation of the NDC. In Ecuador, the provincial governments have been building capacities in the last six years, which has allowed the creation of a Climate Strategy and some provincial projects. However, most of the local actions haven't been incorporated into the implementation plan of the NDC, for a lack of knowledge about the NDC or about the studies needed for its incorporation into the NDC implementation plan.

In this context, Grupo Faro along with the Consortium of Provincial Autonomous Governments of Ecuador (CONGOPE), and with the support of LED LAC created a Guide for the inclusion of the NDC of Ecuador in the subnational local planification. The CONGOPE is the associative entity of the Provincial Autonomous Governments of Ecuador, which has as primary responsibilities, representing the common institutional interests, guaranteeing participation of the executive and legislative functions of the provincial decentralized autonomous governments. LEDS LAC is one of the three Climate Helpdesk advisory initiatives for: NDC Support Cluster, LEDS GP and Partnership on Transparency in the Paris Agreement (PATPA) in cooperation with the NDC Partnership. The Secretariat of the Climate Helpdesk is hosted by the GIZ's Support Project for the Implementation of the Paris Agreement (SPA).















The construction of the "Guide" began with a focus group with five provincial governments: Pastaza, Chimborazo, Pichincha, Guayas, and Esmeraldas, where the deficiencies of information and necessities for capacity building were identified. On a second stage, the document was developed, and shared with the National Designated Authority, the Ministry of Climate Change and Ecological Transition (MAATE). Finally, the guide was presented to the 23 provinces of Ecuador, including the review of the NDC, the requirements for its inclusion in future implementations plans, regarding indicators for its monitoring, evaluation and follow-up, as well as the necessity to create gender action assessments and plans.

The guide construction process and the document allowed the creation of capacities that will allow in the medium and long run the incorporation of the NDC in the local planning as much as the incorporation of the local actions into future implementation plans. But the process also shed light on the necessity of continuous capacity building process within decentralized governments, especially on topics such as gender plans, the creation of local capacities for the determination and actualization of climate risk, and furthermore about the estimation of the potential mitigation.

Objectives

Sharing the process, lessons learned and challenges ahead for the inclusion of NDCs in Subnational Territorial Planning in Ecuador.
