Resumed High-Level Segment

United Nations Climate Change Conference Baku, Republic of Azerbaijan

The resumed high-level segment of COP 29/CMP 19/CMA 6 will be held on Tuesday, 19 and Wednesday, 20 November 2024 and will hear national statements from **those Parties whose Head of State or Government (HOS/G) did not deliver a national statement on 12 and 13 November 2024** during the first part of the high-level segment for Heads of State and Government (HoS/G) held during the World Leaders Climate Action Summit, and representatives of groups who have registered and confirmed their wish to deliver a national or group statement.

Upon conclusion of national statements, the resumed high-level segment will hear statements from Intergovernmental organizations and groups of non-Governmental organizations admitted by the Conference of the Parties.

Parties will have only one opportunity to deliver a national statement during the resumed high-level segment. Parties whose HoS/G delivered a national statement on 12 or 13 November or submitted a written statement in lieu of delivery will not deliver a national statement.

The list below represents speakers for Parties who are confirmed to deliver a national statement or statement on behalf of a UNFCCC negotiating group at the resumed high-level segment of COP 29/CMP 19/CMA 6.

Modalities for the resumed High-Level Segment and delivery of National Statements

To hear delivery of national statements during the resumed HLS on 19 November, access is open to all Parties including overflow. Parties and overflow will not need a ticket. Four seats per Party delegation, will be made available behind the nameplate of each Party.

United Nations organizations will not need tickets to access Plenary Hall Nizami for the resumed HLS on 19 November.

Intergovernmental and non-governmental organizations will need a ticket to access the plenary for the morning session of the resumed HLS on 19 November. Two tickets will be provided for each intergovernmental organization to attend the HLS.

NGO Tickets will be issued to the [Constituency Focal Points](#) in recognition of their tireless work throughout the year to coordinate hundreds of organizations to ensure meaningful engagement in the UNFCCC process.

No tickets will be needed for the afternoon session of the HLS on Tuesday, 19 November and the HLS on Wednesday, 20 November 2024.

The above-mentioned tickets can be collected from the Distribution Desk located in the Services Hub in Zone C at the Conference venue on **Saturday, 16 November and Monday, 18 November 2024 between 10:00 and 17:00**. Collection of these tickets will be only on the dates indicated above. The conference badge of the person collecting the tickets will be scanned to confirm receipt. For security reasons, tickets will not be replaced in the event they are lost or misplaced.

Plenary Hall Caspian will be available for the morning session of the HLS on 19 November for those delegates who will not have a seat in Plenary Hall Nizami to view the live webcast of the formal opening of the HLS. **No ticket or secondary overlay is needed to view the live webcast in Plenary Hall Caspian.**

All speakers should ensure that they are in the plenary room at least four speakers ahead for the delivery of their national statement. Speakers will be escorted by an usher during the presentation of the previous speaker from the seat of their delegation to a reserved chair close to the podium. **Speaking slots for those who are not in the plenary at the time for delivery of their statement will be rescheduled to speak at the end of all statements of the same category.**

Given the number of Parties and other observer speakers and the limited amount of time available for statements, it will be necessary to limit the duration of each statement. Representatives are reminded that statements made during the high-level segment should not exceed the **three-minute limit for Parties and 2 minutes for observer organizations**. To be fair to all speakers, time limits will be strictly enforced. An electronic/mechanical device will be used to mark the 3-minutes allotted to Parties and the 2-minutes allotted to observer organizations. This will allow all speakers to deliver their statements. Speakers are strongly encouraged to ensure their statements do not exceed allotted times. Statements on behalf of negotiating groups should not exceed **five minutes**.

National statements will be delivered reflecting protocol order in accordance with the United Nations. The secretariat is not able to accommodate individual requests for changes in a Party's speaking slot. Parties wishing to make a change should arrange to exchange slots with another Party in the same rank, and both Parties jointly notify the secretariat of the agreement that has been reached. Hard copies of statements will not be circulated in the Plenary during the high-level segment. Full texts of official statements will be posted on the UNFCCC website. To have statements posted on the UNFCCC website, Parties speaking at the high-level segment on 19 and 20 November are requested to send an electronic file containing the statement in advance to cophls@unfccc.int.

Should Parties not wish to speak but prefer only to have their statements uploaded to the UNFCCC website, the secretariat will arrange to have this done and enter the statement in the records of the Conference. Parties interested in taking up this option should communicate their interest in writing to the External Relations office at cophls@unfccc.int or to the External Relations team, who will also be located at the front of the plenary during the high-level segment.

Should Parties not wish to speak but prefer only to have their statements uploaded to the UNFCCC website on 20 November, following the delivery of national statements. The secretariat will arrange to have this done and enter the statement in the records of the Conference. Parties interested in taking up this option should communicate their interest in writing to the External Relations office by sending their statements to the External Relations office at cophls@unfccc.int no later than Wednesday, 20 November or to the External Relations team, who will also be located at the front of the plenary during the high-level segment.

Interpretation

The United Nations Department for General Assembly and Conference Management (DGACM) is responsible for providing simultaneous interpretation in the six official languages of the United Nations (Arabic, Chinese, English, French, Russian and Spanish) for the high-level segments. The UNFCCC secretariat collaborates with the DGACM team assigned to COP29 to schedule these interpretation services.

It is possible for a speech to be given in a language other than the six official United Nations languages. Parties wishing to deliver their statements in their national language, other than the six UN languages, are requested to inform the secretariat in advance to cophls@unfccc.int. Parties can provide their own interpreter for the duration of their statement only, or a written official English translation and a prompter from the speaker's delegation to support the English booth to check against delivery. Requests for interpretation in another language other than the six official languages of the United Nations shall be made in writing to (cophls@unfccc.int).

To ensure the quality of interpretation of national statements, an electronic copy of the statement should be provided to the Conference Officer at Conference-Officer@unfccc.int and copied to cophls@unfccc.int at least 60 minutes prior to delivery of the statement.

COP 29 - TELEPROMPTER GUIDELINES

File delivery and format

The file has to be delivered in **Word format** (.doc or .docx)

No other format is compatible with the prompter.

By e-mail, you can send the file to: copteleprompter@gmail.com and cophls@unfccc.int

Please be precise in subject line: date of speech, country, title, name of speaker, version

or via **USB** at the venue (please call UNFCCC contact below)

Please **call** UNFCCC contact below prior to your email or USB delivery.

Time constrains

A minimum of 60 minutes of preparation are required for each speech (*layout, font, space, breaks, etc. ...*)

We recommend the delivery of the script the night before for loading, especially if the file is not in Latin fonts.

Operator

The operator speaks English only, for other languages, the applicant must provide their **own** operator, or someone to assist the operator.

Operator will not get a badge to access the room. They will meet the UNFCCC contact at the entrance of the plenary 30 minutes prior to their leader's speech. The contact will escort the operator in and out after the speech is delivered

Equipment

The prompter is electrically adjustable, nevertheless, it is better to communicate the height of the guest prior to his/her arrival.
