

Framework Convention on Climate Change

At COP 25 Parties adopted the enhanced Lima work programme on gender and its gender action plan¹. At COP 27 Parties concluded the intermediate review of the implementation of the gender action plan that started at SB 56 in June 2022. The review included amendments to some deliverables and three new activities in priority areas C and E.²

At COP 28 Parties agreed further stipulation and amendments on the final review of the implementation of the gender action plan which the SBI has been requested to initiate at its sixtieth session in June 2024 and to conclude it at its sixty-first session in November 2024.³

The secretariat makes available this informal document to present the gender action plan agreed under the Lima work programme on gender adopted at COP 25 with the additions agreed during the intermediate review of the implementation of the gender action plan at COP 27 and the amendments and additions agreed at COP 28.

Amendments and additions to the original table agreed at COP 27 are presented in cursive blue font. Respective relevant excerpts of text agreed at COP 28 are presented in cursive, orange, underlined font. Text that has been superseded is struck through.
