National Communications (NCs)

GEF has supported 484 NCs since 1995

- 150 countries
- \$286 million total
- Up to \$500,000 from set-aside
- Some countries have chosen to complement with additional STAR resources


22 NCs supported within last year (GEF-7)

- NC 4 (16), NC 2 (2), NC 3 (2), NC 5 and NC 8
- \$12.3 million total

Includes support for Belarus (NC 1, 6, 7), Croatia (NC 1), Lithuania (NC 1), Kazakhstan (NC 3 (3-6), 8), Slovenia (NC 1), Turkey (NC 1, 2, 3 (3-6), 7)

Biennial Update Reports (BURs)

GEF has supported 184 BURs since 2012

- 129 countries
- \$72 million total
- Up to \$352,000 from set-aside
- Some countries have chosen to complement with additional STAR resources


19 BURs supported last year (GEF-7)

- \$7 million total

Global Support Programme (GSP)



- Jointly implemented by UNDP and UNEP
- 5 year program (2015-2020)
- Reviews, technical support and backstopping of NCs and BURs
- Training and sharing best practices on GHG inventories, IPCC guidelines, vulnerability & adaptation assessments, mitigation actions, mainstreaming gender, collaboration with bodies such as with CGE
- Supported South-South communities of practice
- Supported over 120 countries to date
- Support previously provided through Support Programme



Capacity-building Initiative for Transparency (CBIT)


PRIORITIES AT PORTFOLIO LEVEL

- 48 countries
- \$66.5 million total for national projects
- Set-aside resources, with CBIT Trust Fund (until October 2018) and GEF Trust Fund (from July 2018)

Global support for CBIT



- \$7.2 million total






CBIT Programming Status as of June 15, 2019


GLOBAL ENVIRONMENT FACILITY

CBIT Global Coordination Platform

- Brings together transparency practitioners
 - Enable coordination and inform on CBIT projects
 - Facilitate access to emerging practices, methodologies, and guidance on transparency of climate action and support
 - Identify needs and gaps in national transparency systems
 - Share lessons learned through regional and global meetings
 - Supported 3 annual global technical workshops
 - Launched in April 2017
- NC/BUR GSP and CBIT Global Coordination Platform to merge, starting 2020
 - One stop-shop for technical support, knowledgeand best practice-sharing, and capacity-building
 - Regional, global, and thematic levels



Early Lessons Learned and Observations



- ✓ Clarify incremental nature of proposed activities
 - → Build on National Communications and BURs



- ✓ Utilize existing analysis of gaps and barriers
- ✓ Highlight linkages to NDC and enhanced transparency framework



- ✓ Demonstrate agency's comparative advantage
- ✓ Undertake work to respond to COP 24 guidance
 - → Provision of support for biennial transparency reports
 - → Enhance efficiency of support provision for reporting under Article 13





COP 24 Guidance on Biennial Transparency Reports

Decision 18/CMA.1, Modalities, procedures and guidelines for the transparency framework for action and support referred to in Article 13 of the Paris Agreement

Urged and requested the Global Environment Facility, as an operating entity of the Financial Mechanism, throughout its replenishment cycles, to support developing country Parties in preparing their first and subsequent biennial transparency reports. (para 8)

Encouraged the Global Environment Facility to consider options for improving the efficiency of the process for providing support for reporting under Article 13 of the Paris Agreement, in particular for addressing the challenges in the application process, including by potentially providing an avenue for Parties to apply for funding for more than one report through the same application in each replenishment period. (para 9)

Urged the Global Environment Facility and its implementing and executing agencies and encourages the Global Environment Facility Council to consider options for improving the efficiency of the process for providing support for reporting under Article 13 of the Paris Agreement, including through better streamlining of the processes related to applications, implementation plans and signing of grant agreements (para 10)

Requested the Global Environment Facility to continue to support the operation of the Capacity-building Initiative for Transparency as a priority reporting-related need. (para 11)
