

 Support to develop and revise mitigation and adaptation targets, MRV systems, implementation strategies, and impact assessments (including costbenefit analysis)

Global NDC Conference

Hosted by the German Ministry for Economic Affairs and Climate Action, the <u>Global NDC Conference</u> has been jointly organized by SPA, the NDC Partnership and UNDP in 2017, 2019 and 2023.

This international forum presents a space for strengthening networks, showcasing innovative ideas, building momentum, reflecting, and clarifying the NDC formulation and implementation processes that lead to ambitious climate policy and action.

Therefore, **SPA is able to offer country driven and targeted support, including:**


- Technical assistance for NDC Enhancement and LT-LEDs Development



Accounting for Nationally Determined Contributions

The Guidance provides structure to the process of establishing NDC accounting. It is applicable to two general types of mitigation targets distinguished by their reference period: the Base year target and baseline scenario target. The Guidance is complemented by an accompanying Excel calculation tool, which aims to help countries to implement the Guidance.

Enhancing NDCs through Nature- Based Solutions

The tool provides 8 approaches that can be used in addition to an overview of various definitions of nature-based solutions in the context of climate change. The tool gives a wholistic overview by showing example actions, ecosystem services and the potential climate and social benefits.
