**Matters relating to the global stocktake: Procedural and logistical elements of the overall global stocktake process**

*[The Conference of the Parties serving as the meeting of the Parties to the Paris Agreement,*

*Recalling Article 14 of the Paris Agreement,*

*Recalling decision 19/CMA.1,*

*Recalling decision 1/CMA.5,*

1. *Recognizes* the importance of inclusivity in all aspects of the global stocktake process and encourages the meaningful participation of non-Party stakeholders in the process, including through the climate high-level champions and the Marrakech Partnership for Global Climate Action;
2. *Recalls* the sources of input of the global stocktake, including paragraphs 35–37 of decision 19/CMA.1, and also recalls paragraph 60 of document FCCC/SBSTA/2021/3 in this regard;
3. *Requests* the secretariat to further improve the online availability of all inputs to the global stocktake;
4. *[Recalls paragraph 24 of decision 19/CMA.1 and encourages the relevant constituted bodies and forums and other institutional arrangements under or serving the Paris Agreement and/or the Convention, including those established after the adoption of decision 19/CMA.1, to consider opportunities for streamlining information provided in their reports to the global stocktake without compromising the quality and integrity of the information contained therein;]*

**Option 1:** *Encourages* the scientific community to provide inputs to feed into the global stocktake, recognising the importance of the outputs of the Intergovernmental Panel on Climate Change to the global stocktake, [as well as the importance of comprehensive and representative scientific inputs from developing countries to this process][as well as relevant reports from regional groups and institutions], and *invites* the Intergovernmental Panel on Climate Change and other relevant organizations to [structure][organise][align its work] [consider how best] to provide [relevant and timely information] [such critical inputs] for the global stocktake, [in a timely manner] [as available];

**Option 2:** *Encourages* the timely provision of available inputs from the scientific community, including the Intergovernmental Panel on Climate Change and other relevant organizations, on the best available science to feed into the global stocktake, and *invites* these organisations to consider how best to provide such critical inputs for the global stocktake;

6. *[Requests the Chair of the Subsidiary Body for Scientific and Technological Advice to organize special events, pursuant to paragraph [20 and] 29 of decision 19/CMA.1, in cooperation with the Intergovernmental Panel on Climate Change, to enable a focused scientific and technical exchange of information on the Intergovernmental Panel on Climate Change's findings during the most recent assessment cycle and inform the relevant global stocktake, and to prepare for such events using the Subsidiary Body for Scientific and Technological Advice–Intergovernmental Panel on Climate Change Joint Working Group;]*

7. *Recalls* Article 14 of the Paris Agreement, paragraph 6 of decision 19/CMA.1, [and decision 1/CMA.5];

8. *Reaffirms* that the technical dialogue will organize its work in line with taking stock of the implementation of the Paris Agreement to assess the collective progress towards achieving its purpose and long-term goals, including under Article 2, paragraph 1(a–c), in the thematic areas [under paragraph 6(b) of decision 19/CMA.1][of mitigation, adaptation and means of implementation and support, noting, in this context, that the global stocktake [may][will] take into account, as appropriate, efforts related to its work that:

(a) (a) Address the social and economic consequences and impacts of response measures;

(b) (b) Avert, minimize and address loss and damage associated with the adverse effects of climate change;]

9. [*Encourages* the co-facilitators of the technical dialogue to allow for consideration of emerging issues, as appropriate, [that are the subject of work done by mandated constituted bodies under the Paris Agreement] including those related to the key elements for the implementation of the Paris Agreement]

10. [*Decides* that the outline of the decision taken by Parties for the second global stocktake will follow the same outline as the first global stocktake]

11. [*Recalls* paragraph 8 of decision 19/CMA.1;]

12. [*Recalls* paragraph 20 of decision 19/CMA.1;]

13. [*Notes* that the technical assessment component of the second global stocktake will [conclude in 2027, and] include a total of [three][two] technical dialogues, including intersessional work as necessary] [with the consideration of outputs component taking place in 2028;][*Decides* that the technical assessment components of the second and subsequent global stocktake will include three technical dialogues, [unless critical information emerges thereafter that is essential for informing Parties deliberations];]

14. [*Encourages* the co-facilitators of the technical dialogue to consider including in the overarching factual synthesis of their summary reports a technical annex setting out practical options for supporting implementation and highlighting lessons learned, good practices, challenges, barriers and opportunities;]

15. [*Notes* that the technical assessment and consideration of outputs components of the global stocktake may overlap to allow sufficient time for the consideration of outputs;]

16. *Decides* the joint contact group on the global stocktake will start the consideration of outputs component [at least [two][three]][three] subsidiary body sessions before the relevant session of the Conference of the Parties serving as the meeting of the Parties to the Paris Agreement at which the consideration of outputs component of each global stocktake is scheduled to conclude;

17. *Requests* the Chairs of the Subsidiary Body for Scientific and Technological Advice and the Subsidiary Body for Implementation to ensure sufficient time for each component of the global stocktake, particularly the consideration of outputs component, while taking into account lessons learned from the first global stocktake, as well as the constraints faced by Parties and other stakeholders with limited capacity, and notes that this time may include intersessional work as appropriate;

18. [*Notes* that the high-level committee for the consideration of outputs component for the second and subsequent global stocktakes [shall be composed of the incoming and current Presidencies] [will consist of the three Presidencies presiding during the duration of the global stocktake process] and the Chairs of the Subsidiary Body for Scientific and Technological Advice and the Subsidiary Body for Implementation and] urges the high-level committee to conduct its activities in a timely manner;]

19. *Takes note* of the estimated budgetary implications of the activities to be undertaken by the secretariat referred to in this decision;

20. *Requests* that the actions of the secretariat called for in this decision be undertaken subject to the availability of financial resources.]
