

UK Proposal for a Structure for x/CMA.5 Decision on the Glasgow-Sharm el Sheikh Work Programme on the Global Goal on Adaptation

The UK is pleased to make a proposal under the Subsidiary Body for Implementation agenda item 11 and Subsidiary Body for Scientific and Technological Advice agenda item 5 to support the negotiations at SB58.

1. Preambular paragraphs

Including: recalling of Article 7.1 of the Paris Agreement, Decision 7/CMA.3 and Decision 3/CMA.4; welcoming the findings of the Intergovernmental Panel on Climate Change Working Group II Report on Impacts, Adaptation and Vulnerability.

2. Welcoming the work & capturing progress on the Glasgow Sharm el Sheikh Work Programme on the Global Goal on Adaptation

Including: welcoming the work to date under the 2-year work programme.

3. Framework for the Global Goal on Adaptation

This section will specify the elements of the framework to structure the global agenda on adaptation and enhance adaptation ambition, including the role of:

- All steps of the **iterative adaptation policy cycle** as set out in Decision 3/CMA.4.
- The **themes** as set out in Decision 3/CMA.4, and their relevance in enhancing global adaptation ambition.
- **Cross-cutting considerations** as set out in Decision 3/CMA.4, and how to best integrate them (potentially through the relevant guidance) in countries' plans and priorities.
- **Sources of information** as set out in Decision 3/CMA.4, and particularly nationally-driven targets and priorities on the themes/sectors most relevant to Parties (as found in existing voluntary reporting and adaptation vehicles/instruments).
- **Enabling conditions**: good policy will only succeed if the enablers are in place and barriers removed. Enablers vary for each system/sector, but include elements such as data, finance, capacity building, technology transfer, inclusive governance, research, and engagement & education.
- **External factors**: to capture aspects that are largely independent of national policy, but important for adaptation. This includes global and societal shifts, and geopolitical circumstances (e.g. related to hazard, exposure and vulnerability).

4. Role of relevant stakeholders

Including: the potential role of relevant constituted bodies, institutional arrangements and other stakeholders in implementing activities related to the Framework for the GGA.

5. Links to the Global Stocktake

Including: clarifications following the mandates from the Paris Agreement and as per paragraph 7(c) in Decision 7.CMA/3, the GlaSS should 'contribute to reviewing the overall progress made in achieving the global goal on adaptation as part of the global stocktake referred to in Article 7, paragraph 14 and Article 14 of the Paris Agreement with a view to informing the first and subsequent global stocktakes'.

6. Review of the Framework ahead of the second Global Stocktake

Including: clarifications following the mandate to "review the framework referred to in paragraph 8 above prior to the second global stocktake" in Decision 3/CMA.4.
