

Information note on the GST High-Level Events at COP 28 during the World Climate Action Summit

The Global Stocktake High-Level Committee wishes to share additional information and the updated confirmed list of Parties to speak at the GST High-Level Events.

The events at COP 28 will identify political signals and key messages on the implications of the outcomes of the technical assessment for consideration of Parties. The High-Level Events will be held on 1-2 December 2023 during the World Climate Action Summit and as follows:

GST High-Level Event on Adaptation Friday, 1 December from 16:30 to 18:30 (UAE time)

GST High-Level Event on Means of Implementation Saturday, 2 December from 09:00 to 11:00 (UAE time)

GST High-Level Event on Mitigation

Saturday, 2 December from 13:30 to 15:30 (UAE time)

This information note contains relevant information and guidance on the GST High-Level Events.




Confirmation of High-Level Speakers

The GST High-level Events will be open to Heads of States and Governments (HoS/G), heads of UN organizations and Specialized Agencies and Intergovernmental Organizations and representatives of NGO Constituencies who are duly registered for the events through the UNFCCC secretariat. HoS/G will be accorded priority status to deliver their remarks, in line with the guidance provided by the committee. Special consideration will be given to Parties and observer States that have expressed interest to engage during the events at ministerial level in exceptional cases. Parties and observer States are hence urged to confirm their representation level, if they have not already done so, by utilizing the provided emails as soon as possible.

Admission to High-Level Event meeting room - MR11

The following protocol will be adhered to for admission to the GST High-Level Events for all registered delegates. Please note that Party speakers can be accompanied by one member of their delegation.

a) Head of State and Governments: a.All Heads of States and Governments registered for the event with a Lapel pin will be admitted to the meeting room. All Platinum and Bronze badge holders accompanying a HoS/G will be admitted to the meeting room. In cases where the accompanying delegate does not have the listed badges, the secretariat will issue a (one) ticket accordingly, upon request.



- **b) Ministerial delegates:** Ministerial delegates registered for the event with a Platinum or Bronze badge will be admitted to the meeting room. Registered ministerial delegates will be issued with an event ticket in the absence of the forementioned badges, upon request.
- c) UN Agencies, International Organizations, Observer Constituencies and other non-Party Stakeholders: All other delegates duly registered through the secretariat will be issued with event tickets beforehand by the GST Team.

**Admission to the GST High-Level Events is limited to registered high-level participants only.

Seating plan and arrangements

High-Level delegates that will deliver remarks will be assigned seats in alphabetical order, displayed by nameplates containing the name of country or institution at the meeting table. Delegates accompanying Party speakers are requested to occupy the advisory row accordingly. One representative of each NGO Constituency without a speaking role will also be assigned a seat in the advisory row.

Streaming

The GST High-Level events will be streamed through the COP 28 platform accessible to all COP 28 registered participants.

Interpretation

Simultaneous interpretation in all six UN official languages will be provided.

Allocation of time

In light of the interests expressed by many HoS/G to take part in the GST High-Level Events and to allow for maximum participation across the three events, the committee recommends the following allocation of time for speakers:

Role	Allocated Time
Heads of State/ Government	3 minutes
Ministerial delegates	3 minutes
Head of UN organizations and Specialized Agencies, and Intergovernmental Organizations	2 minutes
Representative of NGO Constituency	2 minutes

^{**} Speakers are kindly requested to adhere to the allocated time and to please note that a time keeping "bell" will be utilized by the moderator during the event.
