Information on the delay in submission of seventh national communications from Parties included in Annex I to the Convention that are also Parties to the Kyoto Protocol

Note by the secretariat

- 1. This note provides information on the delay in submission of seventh national communications from Parties included in Annex I to the Convention (Annex I Parties) that are also Parties to the Kyoto Protocol. It includes information available as of 27 April 2018, and covers only information on Parties included in Annex I to the Convention that are also Parties to the Kyoto Protocol.
- 2. Through decision 9/CP.16, Annex I Parties were requested to submit their seventh national communications under the Convention by 1 January 2018 in accordance with Article 12, paragraphs 1 and 2, of the Convention. Parties included in Annex I to the Convention that are also Parties to the Kyoto Protocol shall include in their seventh national communications the necessary supplementary information required under the guidelines for reporting supplementary information under Article 7, paragraph 2, of the Kyoto Protocol, as contained in the annex to decision 15/CMP.1.
- 3. The "Guidelines for review under Article 8 of the Kyoto Protocol" (as contained in the annex to decision 22/CMP.1) stipulate that "If a Party included in Annex I expects difficulties with the timeliness of its national communication submission, it should inform the secretariat before the due date of the submission. If the national communication is not submitted within six weeks after the due date, the delay shall be brought to the attention of the COP/MOP and the Compliance Committee and made public" (para. 139).
- 4. At the time of publication of this note, the secretariat had received seventh national communications from 38 Annex I Parties that are also Parties to the Kyoto Protocol. Four Parties, namely Belarus, Croatia, Turkey and Ukraine, have not submitted their seventh national communications yet. Out of these four Parties, three sent the notifications that they experience difficulties with the timeliness of their submissions and will submit their seventh national communications with a significant delay.
- 5. Only 28 Annex I Parties that are also Parties to the Kyoto Protocol have submitted their seventh national communications by the due date, that was 1 January 2018. Six Parties submitted within six weeks after the due date (i.e. before 12 February 2018), of which only one sent the notification informing the secretariat about its difficulties with the timely submission. Four Parties submitted after six weeks after the due date, out of which three sent the notification informing the secretariat about the planned date of submission.
- 6. Information on the status of submission of the seventh national communications as at 27 April 2018 is included in table 1.
