Introduction:

Aligned with the temperature objectives outlined in the Paris Agreement, the commitment remains steadfast in keeping the goal of limiting global warming to 1.5 degrees Celsius within reach. Essential to this endeavor is the development of Nationally Determined Contributions (NDCs) that are not only technically robust but also firmly rooted in national ownership and drive, intertwined with sustainable development objectives, and, critically, executable and financially viable.

Besides, the emphasis lies in enhancing ambition and offering guidance, especially for the LatAm region to the outcomes of the Global stock take and the new update of the NDC3.0. Introducing the Nationally Determined Contributions (NDCs) training program, our aim is to furnish participants with a comprehensive grasp of the involved in crafting impactful NDCs.

Tailored specifically for government representatives, this program is designed to impart the requisite knowledge and expertise to formulate ambitious yet pragmatic NDCs that contribute significantly to the global climate agenda. Encompassing various facets of NDC development, from target establishment to mitigation strategies, adaptation measures, financial frameworks, and implementation mechanisms, this training endeavors to empower participants to navigate the complexities of NDC updating with confidence and efficacy

Program Objectives:

- Present the key messages from the first Global Stock Take that were discussed at COP28 in Dubai and continue to move forward with updating NDC 3.0
- Provide additional guidance for the design of NDCs
- Explore in-country experiences to inform the setting of ambitious and achievable targets in NDCs through country case studies.
- Understand adaptation measures and resilience-building strategies to address climate impacts.
- Identify financing options and mechanisms for the implementation of NDCs.
- Provide additional guidance for information on the Progress Update of NDCs.





Duration: The program is scheduled for two days, with each session lasting 90 minutes per day.

Target Audience: The training program is designed for government officials, policymakers, climate change practitioners, researchers, and professionals working in the fields of climate change, sustainability, and environmental policy.
