MESSAGE TO CONSTITUENCIES OF NON-GOVERNMENTAL ORGANIZATIONS

Third dialogue under the United Arab Emirates Just Transition Work Programme

22 - 23 May 2025 Panama City, Panama

I refer to the <u>Message to Parties and Observers</u> dated 2 April 2025 regarding the discussion topic for the third dialogue under the United Arab Emirates Just Transition Work Programme (UAE JTWP) and am pleased to invite constituencies of admitted non-governmental organizations (NGOs) to the third dialogue under the UAE JTWP, scheduled to take place during <u>Climate Week-1 2025</u>: <u>Dialogues for</u> <u>Ambition and Implementation</u>¹. The new Climate Weeks will have a global focus.

The third dialogue is being organized pursuant to decision 3/CMA.5, by which the CMA decided that at least two dialogues shall be held each year as part of the UAE JTWP and requested the secretariat to organize those dialogues under the guidance of the Chair of SBSTA and Chair of SBI.

Pursuant to the same decision, the Chair of the Subsidiary Body for Scientific and Technological Advice (SBSTA), Adonia Ayebare, and Chair of the Subsidiary Body for Implementation (SBI), Julia Gardiner, have selected the topic: "*Approaches to enhancing adaptation and climate resilience in the context of just transitions*".

Under the guidance of the Chairs of the SBSTA and SBI, the third dialogue will take place in **Panama City**, Panama from **22-23 May 2025** in a hybrid format. One full-day session is planned on 22 May and a half-day session is planned on 23 May.

Nomination and registration

NGO observer nominations should be communicated to the secretariat by NGO constituency focal points (CFPs). Representatives of admitted NGOs nominated by CFPs must register using the online registration form, which will be communicated to the nominated participants.

Kindly note that, given space limitations, **four representatives per constituency will be permitted to participate as observers in-person in the third dialogue under the UAE JTWP**. CFPs are requested to nominate two participants from a developed country and two participants from a developing country from their constituency for in-person participation. CFPs are also invited to nominate up to **four** representatives to participate **virtually** in the third dialogue under the UAE JTWP via the active virtual participation modality - two participants from developed countries and two participants from developing countries. CFPs are requested to submit their nomination list via cool@unfccc.int no later than **11 April 2025**, **CEST 23:59**.

Once a participant has been nominated for an event, they will receive an email with registration details via Indico.UN. Logistical details related to participation will be shared directly with registered participants. For those who are not nominated and are interested in following the third dialogue under the UAE JTWP, it will also be broadcast live.

In accordance with decision 3/CMA.5, paragraph 8, observers and non-Party stakeholders are kindly reminded to submit their views on opportunities, best practices, actionable solutions, challenges and barriers relevant to the topic of the third dialogue via the <u>submission portal</u> as early as possible, and no later than four weeks before the third dialogue.

The Chair of SBSTA and Chair of SBI as well as the secretariat look forward to receiving nominations and welcoming participants to the third dialogue under the work programme.
