### **Response Measures Outcomes from COP28**

- The secretariat to organize a two-day hybrid global dialogue on the impacts of the implementation of response measures in conjunction with intersessional meetings of the KCI in 2024 and 2025. 4 weeks before each global dialogue - SB Chairs to decide on and communicate the topics to be discussed.
- SB to review the functions, work programme and modalities of the forum and its KCI every five years, starting at SB 69 (2028), with a view to enhancing the effectiveness of the forum and its KCI and providing recommendations for consideration at COP, CMP, CMA.
- SB 61 to consider and adopt the KCI five-year workplan in line with the Forum's functions, work programme and modalities, taking into account relevant policy issues of concern to Parties



## **Response Measures Outcomes from COP28**

- the forum and KCI to implement activities as conclusion to mid-term review. Specific mandates relevant for the SB includes:
  - SB 62 to organize a technical event on country case studies pertaining to activity 7 of the workplan, in line with the agreed modalities in the workplan
  - SB 62 to organize a technical event on national and subnational legislation, action plans, frameworks and other structural factors for just transition and economic diversification and transformation
  - SB 60 to organize a technical event on the positive and negative impacts associated with low and zero emission transport technologies
  - SB 62 to organize a technical event on the assessment of the environmental, social and economic co-benefits of climate change policies and actions informed by the best available science, including the use of existing tools and methodologies



## **Response Measures Outcomes from COP28**

- Adopted the updated functions, work programme and modalities of the forum and its Katowice Committee on Impacts. SB to consider and recommend the updated of the rules of procedure of the KCI for consideration and adoption at COP 29, CMP 19, CMA 6 (November 2024)
- Adopted the recommendations pertaining to activities 2, 8 and 9 of the workplan, and requested KCI to report, in its annual report, on progress in implementing the recommendations

148. Requests the forum and its Katowice Committee on Impacts to intensify efforts to implement the recommendations outlined in relevant decisions of the Conference of the Parties, the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol and the Conference of the Parties serving as the meeting of the Parties to the Paris Agreement, including by enhancing cooperation among Parties, stakeholders, external organizations, experts and institutions and by enabling the exchange of information, experience and best practices among Parties with a view to increasing their resilience to these impacts;

149. *Also requests* the forum and its Katowice Committee on Impacts in performing their functions to implement in line with the best available science and take into account different national circumstances;
