

Katowice Committee of Experts on the Impacts of the Implementation of Response Measures

Third meeting, Bonn,

Virtual Meeting, 5–9 October 2020

Information note by the Co-Chairs of the Katowice Committee of Experts

I. Mandate:

1. Decision <u>7/CMA.1</u> established the Katowice Committee of Experts on the impacts of the implementation of response measures (KCI). The decision requires that the KCI shall meet twice a year, for two days per meeting, in conjunction with the meetings of the subsidiary bodies. Further, workplan of the forum on the impact of the implementation of response measures and its KCI is adopted by decision 4/COP.25, 4/CMP.15 and <u>4/CMA.2</u>.

II. Objective:

2. The KCI meetings for 2020 were planned to be held in conjunction with SB 52 and SB 53 in June 2020 and November 2020 respectively. The COP Bureau agreed to postpone its 2020 sessions to 2021 due to impact of COVID-19 pandemic. However, the Bureau and the secretariat agreed to keep the momentum of the work on climate change. The Bureau thus requested the secretariat to proceed to organizing mandated and non-mandated events virtually to progress the work, as long as such events do not border on negotiations among Parties. The Bureau also admonished the secretariat to ensure that participation in these virtual meetings are inclusive, and where needed facilitated, to ensure that no one or region is left behind.

3. Pursuant to the guidance of the COP Bureau, the objective of this note is to provide indication of the impact of postponement of SB sessions on the work of the KCI and to propose a way forward for the implementation of activities originally planned to be delivered by the KCI at its meetings in conjunction with SB 52 originally scheduled for 2020.

III. Impact of COVID-19 Pandemic on the KCI's workplan implementation

4. The workplan agreed by decision 4/COP.25, 4/CMP.15 and 4/CMA.2 mandates the KCI to implement two activities at its 3rd meeting and one activity at its 4th meeting. In addition, the KCI must undertake a training on incorporating gender consideration in its workplan and to prepare its annual report. The implementation of these activities is impacted due to the postponement of SB 52 and SB 53 from 2020 to 2021, which has a cascading effect on the activities in the workplan of KCI to be undertaken at its meetings along with SB 54 and SB 55, which were also expected to be held in 2021. Table 1 below presents the activities which are impacted due to postponement of SB sessions of 2020, and by default SB sessions in 2021. The table does not provide impacts of the COVID-19 on the KCI's six-year workplan as a whole. These will have to be assessed generally at KCI subsequent meetings.

IV. Proposal

5. It is proposed that KCI 3 is held virtually in the month of October where the overall impact(s) of COVID-19 on the workplan of the KCI will also be discussed. Any further action to address the impacts will be taken in line with the discussions and agreement reached by the KCI.

A. Duration

6. To meet the working time of two-day meeting, it is proposed to spread the virtual meeting over five days, three hours per day. This arrangement, as discussed in detailed below, will ensure that the time for the meeting is convenient and provides some level of comfort to all KCI members who are spread across different time zones, and also to facilitate productive use of time.

7. The KCI 3 meeting will take place from 5 - 9 October 2020.

8. Training for KCI members on incorporating gender considerations in the workplan of the KCI will take place on 2 October 2020.

9. A pre-meeting will be organized for KCI members prior to KCI 3 in preparation to the virtual meeting The meeting will include among others, the brief introduction to the Katowice decision, progress by KCI till date, and work ahead of KCI in this year; running through the agenda; present the information contained in this note including distribution of work during the 5 days meeting,

B. Working hours:

10. Considering the time zone of all members (GMT -4 and GMT +8), and seeking to achieve a fairly decent and convenient working hours of the day for all members, a maximum of 3 hours a day, it is proposed that the meeting takes place between 1300-1600 CEST each day, from 5-9 October 2020. The respective timing for participation of all KCI members in the meeting and across the different time zones is provided in Table 2 below
