# Annotations to the provisional agenda

### 1. Opening of the meeting

- 1. **Background:** According to the rules of procedure of the Katowice Committee of Experts on the Impacts of the Implementation of Response Measures (KCI), at least nine members must be present at a meeting to constitute a quorum.
- 2. **Action:** The KCI Co-Chairs will ascertain whether the members present constitute a quorum and will open the meeting.

### 2. Organizational matters

- (a) Adoption of the agenda
  - 3. **Background:** According to its rules of procedure, the KCI shall adopt the agenda at the beginning of each meeting. The provisional agenda for KCI 6 was prepared by the secretariat under the guidance of the KCI Co-Chairs and circulated among KCI members prior to the meeting.<sup>2</sup>
  - 4. **Action:** The KCI will be invited to adopt the agenda for the meeting.

#### (b) Organization of work

- 5. **Background:** KCI 6 will be held in Bonn from 2 to 3 June 2022 and will be open to attendance as observers by Parties and observer organizations, except where otherwise decided by the KCI. The meeting will be webcast live.
- A tentative work schedule for the meeting was prepared by the secretariat under the guidance of the KCI Co-Chairs, which presents a proposed order and indicative timeline for taking up the agenda items.
- 7. **Action:** The KCI will be invited to take note of the proposed organization of the work for the meeting.

- (c) Membership matters
  - 8. **Background:** The COP 26, CMP 16 and CMA 3 adopted rules of procedure of the KCI containing revised information on the initial term of KCI members<sup>3</sup>.
  - At KCI 6, the secretariat will provide an update on the status of membership of the KCI.
  - 10. **Action:** The KCI will be invited to take note of its membership status.

### 3. Update on relevant meetings, events and initiatives

- (a) Outcomes of the United Nations Climate Change Conference in Glasgow
  - 11. **Background:** At the United Nations Climate Change Conference that took place from 31 October to 13 November 2021 in Glasgow, decisions relevant to the UNFCCC constituted bodies and to response measures were adopted.
  - 12. At KCI 6, the secretariat will present the main outcomes of the Glasgow Conference of relevance to the work of the KCI.
  - 13. **Action:** The KCI will be invited to take note of the information provided.
- (b) Synthesis report by the Katowice Committee on Impacts as input to the technical assessment component of the first global stocktake
  - 14. **Background:** The Conference of the Parties serving as the meeting of the Parties to the Paris Agreement requested the KCI to prepare by February 2022, with the assistance of the secretariat, a synthesis report on relevant work of the forum on the impact of the implementation of response measures and its KCI as input to the technical assessment component of the first global stocktake.
  - 15. The synthesis report has been forwarded to the co-facilitators of the technical assessment and made available on the UNFCCC website.<sup>4</sup>
  - 16. **Action:** The KCI will be invited to take note of the synthesis report.

# 4. Implementation of the workplan of the Katowice Committee on Impacts for 2020–2025

- (a) Identify country-driven strategies and best practices on just transition of the workforce and creation of decent work and quality jobs and on economic diversification and transformation focusing on challenges and opportunities from the implementation of low greenhouse gas emission policies and strategies towards the achievement of sustainable development (activity 2)
  - 17. **Background:** As per the Activity 2 of the workplan of the forum and its KCI, the KCI is to implement this activity at its meetings held in conjunction with SB 54 and 58. The activity is implemented through input from experts, practitioners and relevant organizations, and concrete examples. KCI 4 agreed on a strategy for implementing the activity.
  - 18. At KCI 6, the member of the open-ended working group of the KCI leading on the activity, supported by the secretariat, will be invited to present the draft compilation of concrete examples for consideration by the KCI.
  - 19. **Action:** The KCI will be invited to:
    - Consider the draft compilation of concrete examples and provide guidance to the open-ended working group for it to improve and finalize the compilation after the meeting;

b) Agree on further steps for implementing this activity at SB 58, including providing recommendations and/or key findings, as applicable, for inclusion in the meeting report for consideration by the forum.

- (b) Build awareness and understanding of Parties and other stakeholders to assess the economic impacts of potential new industries and businesses resulting from the implementation of response measures with a view to maximizing the positive and minimizing the negative impacts of the implementation of response measures (activity 5)
  - 20. **Background:** As per the Activity 5 of the workplan of the forum and its KCI, the KCI is to implement this activity at its meeting in conjunction with SB 57. The activity is implemented through receiving input from experts, practitioners and relevant organizations, and technical paper. KCI 5 agreed on a strategy for implementing the activity and an outline of the technical paper. The KCI issued a call for inputs on 3 December 2021.
  - 21. At KCI 6, the member of the open-ended working group of the KCI leading on the activity, supported by the secretariat, will be invited to provide an update on the progress of work on the technical paper.
  - 22. **Action:** The KCI will be invited to:
    - a) Take note of the update on the progress of the work;
    - b) Provide guidance for further developing the technical paper with a view to finalizing it at its meeting to be held in conjunction with SB 57.

  - 23. **Background:** As per the Activity 9 of the workplan of the forum and its KCI, the KCI is to implement this activity at its meetings held in conjunction with SB 56 and 62 using modality input from experts, practitioners and relevant organizations, and technical paper. KCI 5 agreed on a strategy for implementing the activity and an outline of the technical paper. The KCI issued a call for inputs on 3 December 2021.
  - 24. At KCI 6, the member of the open-ended working group of the KCI leading on the activity, supported by the secretariat and a consultant, will be invited to present the draft technical paper for consideration by the KCI.
  - 25. **Action:** The KCI will be invited to consider the draft technical paper and to provide guidance for further improving it with a view to:
    - a) Finalizing it at its meeting to be held in conjunction with SB 62;
    - b) Providing recommendations and/or key findings, as applicable, for inclusion in the meeting report for consideration by the forum.

- (d) Facilitate, exchange and share experiences and best practices on the assessment of the environmental, social and economic co-benefits of climate change policies and actions informed by the best available science, including the use of existing tools and methodologies (activity 11)
  - 26. **Background:** As per the Activity 11 of the workplan of the forum and its KCI, the KCI is to implement this activity at its meetings held in conjunction with SB 55 and 57 using modality input from experts, practitioners and relevant organizations. KCI 5 agreed on a strategy for implementing the activity. The KCI issued a call for inputs on 3 December 2021.
  - 27. At KCI 6, the secretariat will present a summary of the submissions received in response to the call for inputs, followed by a discussion of the KCI on the activity.
  - 28. **Action:** The KCI will be invited to:
    - a) Take note of the summary and the discussion;
    - b) Agree on further steps for implementing the activity and consider providing recommendations and/or key findings, as applicable, for inclusion in the meeting report for consideration by the forum.
- (e) Strategies for implementing workplan activities
  - 29. **Background:** KCI 5 agreed that deliberations would continue intersessionally via electronic means on the draft strategies for implementing its workplan activities to be delivered in 2023–2024 with a view to the strategies being adopted at KCI 6.
  - 30. **Action:** The KCI will be invited to discuss and agree on strategies for implementing the mandated activities for 2023–2024 included in its workplan.

### 5. Mainstreaming gender considerations

- 31. Background: The KCI is to integrate gender consideration into all its activities, initiate an informal gender and response measures network and consider establishing indicators for measuring gender integration; and the KCI gender focal points are to monitor progress and update the KCI at each of its meeting.
- 32. At KCI 6, the KCI gender focal points, supported by the secretariat, will report on progress in mainstreaming gender considerations and share their views on the future work of the KCI on this matter.
- 33. **Action:** The KCI will be invited to take note of the report of the gender focal points and provide further guidance for the work of the KCI on this matter.

### 6. Communication and outreach strategy

- 34. **Background:** KCI 5 requested the secretariat to prepare a draft communication and outreach strategy for consideration at KCI 6.
- 35. At KCI 6, the member of the open-ended working group of the KCI leading on the activity, supported by the secretariat and a consultant, will present the draft communication and outreach strategy.

36. **Action:** The KCI will be invited to provide comments and guidance on the draft communication and outreach strategy.

  - 38. **Action:** the KCI will be invited to take note of the information provided.
- (b) Any other matters
  - 39. The KCI may wish to consider any other matters raised at the meeting and to agree on any follow-up activities, as appropriate.

## 8. Date and venue of the next meeting

- 40. **Background:** In accordance with its rules of procedure, the KCI shall meet twice per year, for two days per meeting, in conjunction with the sessions of the subsidiary bodies.
- 41. KCI 6 will discuss the dates for the next meeting.
- 42. **Action:** The KCI Co-Chairs will be invited to propose provisional meeting dates for KCI 7 and the KCI will be invited to take note of the dates.

### 9. Closure of the meeting

43. The KCI Co-Chairs will be invited to summarize the key outcomes of and close the meeting.
