Background

- Mandates: (Annex II to decision 4/COP.25, 4/CMP.15 and 4/CMA.2)
 - **Workplan activity 7** – “Facilitate the development and exchange of regional, country- and/or sector-specific case studies and approaches on (1) economic diversification and transformation and just transition of the workforce and creation of decent work and quality jobs, and (2) assessment and analysis of the impacts of the implementation of response measures with a view to understanding the positive and negative impacts”
 - **Modalities** – “KCI to examine existing case studies and identify an area where it may develop a case study, as appropriate.”
 - **Estimated timeline** – “SB 59 and onwards, as decided by the forum/KCI”
 - **KCI 7** – The KCI agreed to finalize the concept note electronically after the meeting taking into account the comments and guidance provided at the meeting and agreed to discuss the activity further at KCI 8



Case study options

22. Based on the aforementioned criteria and upon review of the relevant work (done by the KCI, the forum, and external groups), this concept note proposes the following three options as potential areas where a case study may be developed, as appropriate, by the KCI:
- a. ***Option 1- Country-specific case study:*** Assessing the effects of the global energy transition (such as the reduction of hydrocarbon demand due to global energy transitions and rising climate policies) in a fossil-fuel dependent economy, taking into account people in vulnerable situations, as well as efforts toward economic diversification and transformation and just transition.
 - b. ***Option 2- Region-specific case study:*** Assessing impacts of the implementation of emissions reductions climate policies, on economies, taking into account people in vulnerable situations, as well as efforts toward economic diversification and transformation and just transition.
 - c. ***Option 3- Sector and region-specific case study:*** Assessing impacts of increasing fuel costs on resource-dependent, carbon-intensive tourism sectors, taking into account people in vulnerable situations, as well as efforts toward economic diversification and transformation and just transition.

Agreed Strategy

<p>1) KCI open-ended working group to develop the concept note to examine existing case studies. The KCI open ended working group will identify an area where it develops a case study, the concept note shall include an outline for the case study, timelines for development, with support of secretariat, and consultant if considered necessary, subject to the availability of financial resources;</p> <p>2) KCI holds discussion on the concept note to implement the activity taking into account inputs from experts at the KCI meeting held in conjunction with SB57;</p>	<p>Annex VI to the meeting report of KCI6 (KCI/2022/6/10)</p>
<p>3) Agree on the concept note including activities and time frame for delivery of work via email after the KCI meeting held in conjunction with SB57;</p> <p>4) KCI meeting report will be adopted in advance of the next forum meeting. The KCI meeting report will include recommendations and/or key findings, as applicable, for consideration by the forum.</p>	

24. The final selection of the country/region/sector of the case study would be selected based on inputs from the KCI and decisions by the KCI members.
25. The KCI may consider inviting case studies from other organisations and stakeholders.
26. The KCI may consider the budgetary implications on case study options presented in the concept note.
