# GST summary

---

## GST: TD 1.3 messages ([para 51-55](#))

- 15 submissions stressing the need for promoting partnerships and cooperative initiatives to invest in technology, innovation, green jobs and re-skilling to enable inclusive and just solutions.
- Still lack of modelling scenarios and understanding of the impacts of climate actions on jobs and economic systems.
- highlighted several options to address the impacts of response measures, which are implemented differently across contexts and national circumstances.
- JT as an enabler, challenges pertaining to integrate SD and JT into national development agenda.
- Need to strengthen the capacity and provide necessary tools to undertake just energy transition
