Overall summary

□ Purpose objective and scope

- ❖ importance of a framework for capacity development
- ❖ emphasizes the need to address the impacts of implementation of response measures
- ❖ aims to guide activities related to capacity building, enhancing effectiveness in implementing climate actions
- ❖ intended to contribute to climate ambition and sustainable development by empowering nations to design and implement just transition policies, undertake economic diversification and transformation, and build capacities to address both domestic and cross-border climate policies as they transition towards low greenhouse gas emitting economies.



Guiding principles

- ❑ **Country-driven approach** that considers specific needs, national development priorities, strategies, and initiatives. This approach should be in alignment with existing capacities and processes within the countries, emphasizing the importance of a tailored strategy rather than a universal solution.
 - ❑ **Sustainability and Continuous Progress**
 - ❖ sustainability lies in its continuity and adaptability
 - ❖ The framework should encourage synergies among various international agreements and promote peer-to-peer learning among developing countries.
 - ❖ suggests the development and implementation of various modules and training materials collaboratively with stakeholders to comprehensively address the scope of capacity development required for handling these impacts effectively.
