# Background



**KCI at KCI8 agreed on strategy for implementing activity 10 of the workplan of the forum and its KCI.**

# Reporting Requirements on Response Measures

## Decisions 1/C.P.10

Specific needs and concerns from non-Annex I Parties progress made on support programmes by Annex II Parties to meet the specific needs and circumstances of developing country Parties arising from the impact of the implementation of response measures

## Decisions 2/C.P.17

- Detailed information by each Annex I Party on the assessment of the economic and social consequences of response measures.
- Information by each Annex II Party on the financial support for the purpose of assisting non-Annex I Parties to mitigate emissions and adapt to the adverse effects of climate change and any economic and social consequences of response measures, ...

## Decisions 15/CMP.1 and 3/CMP.11

- Information by each Annex I Party (including Annex I Party without quantified emission limitation and reduction commitments for the second commitment) on how it is striving, under Article 3, paragraph 14, of the Kyoto Protocol, to implement its commitments in such a way as to minimize adverse social, environmental and economic impacts on developing country Parties
- Information by Each Annex I Party on how it strives to implement policies and measures in such a way as to minimize adverse effects, including the adverse effects of climate change, effects on international trade, and social, environmental and economic impacts on other Parties, especially developing country Parties.

## Decisions 18/CMA.1 (ETF)

- Information necessary to track progress on the implementation and achievement of the domestic policies and measures implemented to address the social and economic consequences of response measures by Parties with NDCs with adaptation actions and/or economic diversification plans resulting in mitigation co-benefits. Information includes:

(a)

Sectors and activities associated with the response measures

(b)

Social and economic consequences of the response measures

(c)

Challenges in and barriers to addressing the consequences

(d)

Actions to address the consequences

- Detailed information by each Party on the assessment of economic and social impacts of response measures.

# Guiding Questions



## Question 1

**What are processes in place in your country or organization to systematically identify or collect information on social and economic consequences of impacts of implementation of response measures?**



**The respondent may wish to include information related to institutional arrangement, any other process followed for understanding/ identifying the impacts of implementation of response measures during formulation or during implementation of climate policies**





## Question 2



**How are the qualitative and quantitative information on impacts of implementation of response measures prepared for reporting, in your reports, the social, economic and environmental impacts, including those on other Parties?**

**The respondent may wish to include information on any qualitative or quantitative tools which is used to assessment of social and economic consequences of response measures which informed the country reporting**

# Guiding Questions



## Question 3

**How does the information provided in existing reports contribute to:**

- 1** the assessment of the economic and social consequences of response measures
- 2** the support provided to minimize the adverse impacts and maximize the positive impacts
- 3** understanding the actions taken to minimize the impacts of implementation of response measure

### Guidance

**The respondent may wish to include information whether and/or how the existing reporting requirements and reports by Parties have:**

**prompted socioeconomic impacts assessments by other Parties**

**enhanced understanding of Parties of the actions needed to minimize the adverse impacts of response measures**

**spurred support that is needed by Parties to minimize the adverse impacts and maximize the positive impacts**



## Question 4

**How does the information provided in existing reports contribute to understanding the specific needs and concerns arising from the adverse effects and the opportunities arising from the positive effects of the implementation of response measures.**

### Guidance

**The respondent may include information on how existing reporting requirements enable Parties to understand specific needs and concerns arising from adverse effects and opportunities from positive effects.**

**The reports by Parties contribute to a comprehensive understanding of the implementation of response measures.**

**These reports provide insights into the impacts on the Parties making the reports.**



## Question 5

### **Challenges encountered in preparation for reporting impacts of response measures**



**The respondent may wish to include information on the challenges encountered when preparing the information pertaining to impacts of implementation of response measures or economic and social consequences of response measures. The challenges may include challenges in the process for reporting as well as challenges in identifying the impacts.**
