National adaptation plans

Draft conclusions proposed by the Chair

1. The Subsidiary Body for Implementation (SBI) welcomed the successful conduct of the meeting of Party experts to assess progress made in the process to formulate and implement national adaptation plans (NAPs), held in Sao Tome, Sao Tome and Principe, from 7 to 9 February 2018.

2. The SBI also welcomed the successful conduct of the NAP Expo that took place from 4 to 6 April 2018 in Sharm El Sheikh, Egypt, and the active participation of Parties and other relevant stakeholders and welcomed the offer of the Republic of Korea to host the 2019 NAP Expo.

3. The SBI expressed its gratitude to the Government of Sao Tome and Principe for hosting the meeting referred to in paragraph 1 above, and the Government of Egypt for hosting the NAP Expo referred to in paragraph 2 above.

4. The SBI welcomed the work of the Least Developed Countries Expert Group (LEG), the Adaptation Committee and the secretariat in preparing the following documents:

(a) The summary of progress in the process to formulate and implement NAPs;¹

(b) The report on progress, experience, best practices, lessons learned, gaps, needs and support provided and received in the process to formulate and implement NAPs;²

(c) The report on the Adaptation Committee workshop on accessing the Readiness and Preparatory Support Programme of the Green Climate Fund for adaptation.³

5. The SBI expressed its appreciation to the LEG and the Adaptation Committee for the successful conduct of the meeting referred to in paragraph 1 above, and to the organizations that contributed to the analysis and assessment of progress.⁴

6. The SBI welcomed the work of the LEG in organizing side events during the sessions of the SBI, as appropriate, and invited the LEG to consider extending an invitation to developing country Parties to showcase their examples of national adaptation planning at

the twenty-fourth session of the Conference of the Parties (December 2018), as appropriate, noting the importance of providing examples of national adaptation planning, including benefits and challenges, consistent with the LEG work programme.

7. The SBI agreed to continue consideration of this matter at SBI 49 (December 2018) on the basis of the draft text proposed by the co-facilitators of the informal consultations on this agenda item.⁵
