## **Least Developed Countries Expert Group (LEG)**

Recommendations for addressing the challenges faced by the least developed country (LDCs) in accessing funding and support from the Green Climate Fund (GCF) for the formulation and implementation of national adaptation plans (NAPs) – 22 August 2024

## 1. Mandate

COP 26 requested the LEG to continue to collaborate with the SCF on matters relating to access to the GCF and other funds under the Financial Mechanism by the LDCs for funding the process to formulate and implement NAPs.¹ COP 27 invited the LEG and the Adaptation Committee to continue formulating recommendations on ways to facilitate the mobilization of support for the formulation and implementation of NAPs with a view to addressing the challenges experienced by developing countries in accessing funding and support from the GCF for the formulation and implementation of NAPs, and to submit the recommendations to the SCF for consideration.²

Additionally, SBI 59 requested the LEG to convene a meeting with the Adaptation Fund, the GCF, the GEF and other relevant organizations, as part of NAP Expo 2024, to identify ways to assist the LDCs in expeditiously implementing adaptation action based on priorities identified in their NAPs, and to include recommendations in its reports to the SBI with a view to addressing the challenges, gaps and needs that the LDCs continue to face in accessing funding for implementing NAPs. It also requested the LEG to identify the challenges faced by the LDCs in initiating and/or completing the process of accrediting direct access entities (DAEs) as well as the challenges, gaps and needs faced by the LDCs in gaining approval of projects by their DAEs and include the findings thereon in its report for consideration at SBI 61.<sup>3</sup>

## 2. Recommendations

The table below provides recommendations from the LEG based on the ongoing work of the LEG in capturing progress, gaps and needs, challenges and barriers of the LDCs in the formulation and implementation of NAPs including in accessing support, as well as results of the activities in responding to the mandate from SBI 59.
