Indigenous and local knowledge of flora, fauna, and climate systems is of upmost importance for climate change adaptation responses. Improving sustainable land management could help addressing climate change adaptation, in this way we maximize the limited resources

Challenges include power differentials - the right and access to land tenure, excessive land ownership and intensive agriculture interests. Opportunities include greater appreciation for the role of nature restoration and rightsbased approaches.

Efficient production of safe and sustainable food is important for adaptation - producing more with less inputs and impacts eases land-use pressures. And removing barriers to trade can create environmental benefits, for instance through ACCTS,



There are major opportunities in promoting synergies between adaptation and mitigation through sustainable land management practices. The challenge to robust policy frameworks to address differentiated vulnerabilities, and the unique role indigenous

Opportunities: Inclusion and identification of adaptation action of a diverse group.Challenges: Resources for implementing adaptation action and a blanket policy for all.

Integrating forests into agricultural landscapes can reduce carbon footprints, improve water quality (through reduced run-off), improve biodiversity, and achieve positive animal welfare outcomes (from shade and shelter for livestock)
